

Dundee City Council Community Empowerment Report

2020/21



Purpose

A report to meet Dundee City Council's requirements under ss.32 and 95 of the Community Empowerment Act (Scotland) 2015 to produce an Annual Report on Participation Requests and Community Asset Transfer.

Although there was one Community Asset Transfer application received under the Act it was not a valid application and so is not included in the formal return. However, information is detailed in **Appendix 2**.

Dundee City Council has a voluntary scheme for Community Asset Transfer which runs alongside the Community Empowerment Act 2015. Although not required under the Act, details of Community Asset Transfer pre-applications received and activity under Dundee City Council's voluntary scheme is detailed in **Appendix 2**.

Support

Under ss.32 (d)(ii) and 95 (f)(ii) of the Act we are required to outline what steps we have taken to support groups and individuals through the process of undertaking Participation Requests and Community Asset Transfer respectively.

Since reconfiguring our CLD Service to create a Community Empowerment Team in March 2020, support for Community Asset Transfer and Participation requests has shifted from one officer centrally to locality teams in each of the 8 Multi-Member wards across the city. These teams made up of qualified Community Learning & Development practitioners have meant that organisations are able to access local support and local knowledge which is helping them to engage with stakeholders in that community and has meant more organisations are getting to the pre-application stage of CAT than ever before and has resulted in the first successful Participation Request.

These teams now proactively use CAT and PR as a tool in their suite of community development skills and we are beginning to see a real difference to the community groups who are working in partnership with us in terms of their understanding of these tools and the potential outcomes for the communities they represent.
