DUNDEE TOWN COUNCIL MINUTES - OCTOBER 1566/ OCTOBER 1567

This set of minutes was indexed by Damien Smith, a volunteer with the Friends of Dundee City Archives. As no page numbers are present in the minutes, cataloguing was done on the basis of dates.

No election of new members occurred on a specific day in 1556. Posts filled one by one throughout the year.

Acts

- All acts and statutes decreed by the Council to be enforced without respect of any person (18 June 1567).
- The acts on Wool trading to be enforced, any person not paying wool duty to be taken into custody until payment is made (18 June 1567).
- The acts on merchant sailors wine rations to be enforced, all ships to be provided for and captains to be repaid for any expense (18 June 1567)

Argyligate [Overgate]

- John Kinnaird produces a brief from chancery concerning building a stair on his property at the Argyllgate (29 January 1507).
- A dispute between two property owners on the north side of the Argyllgate settled (9 June 1567).
- James Petrie (burgess) complains Andrew Baxter is encroaching on his property in the Argyllgate (17 July 1567).

Bulwark

- The anchorage dues and customs to be levied only on the dock and bulwark (18 June 1567).

Burgesses

 New conditions concerning the admission of persons to the burgess guild or becoming a burgess freeman (18 June 1567).

Charges

- All charges, ordinary or extraordinary, or debts and damages belonging to the town to be met jointly by the provost, baillies and deacons of crafts (16 November 1566).

Cowgate

- The Cowgate to be paved over, as far as Our Lady's Wynd (4 October 1566).

Court

- Any person absent from the head court after the ringing of the bell to be fined (7 October 1567).

Dewchar, Thomas

- To be given a pension from the Queens Donation Fund for his services to the town (18 June 1567).

Discharge

- Any member of the Council breaking office or opening secret communications to be discharged (26 February 1567).

Keys

 According to ancient custom, the keys of the common kist to the following persons for the year:

James Lovell Andrew Annand Alexander Carnegy (4 October 1566).

Kirk

- No women to bring any children younger than 5 years into the Kirk (7 October 1567).

Kyd, Robert

- The malt, common milne and small customs revenues to be managed by Robert Kyd (16 November 1566).

Libel

In all libel cases witnesses to be produced on the day of renunciation and depositions to be made immediately (18 June 1567).

Middens

- No more middens are allowed in the West Port and all middens at the Burial Wynd and Swine Burn to be removed (4 October 1566).

Murraygate

Robert Drummond, burgess and tenement owner on the North side of the Murraygate complains that his access to the well has been blocked (3 July 1567).

[Overgate] see Argyllgate

<u>Pier</u>

- Work to be done on the pier and bulwark (18 June 1567).
- All craftsmen, sea captains or mariners who do not pay the small customs to contribute towards the work on the bulwark (18 June 1567).

Piermaster

Alex Srimgeour to be piermaster and George Bell his officer (7 October 1567).

Poorbox

- Any money found to be made fraudulently to be placed in the poorbox (7 October 1567).

Ramsay, David (Baillie)

- Appointed collector of the queen's donation for upholding the ministry of this burgh (18 June 1567).
- David Ramsay again elected to the same office (7 October 1567).

Rent

- An act about George Rollok and his rent from the common milnes (4 October 1566).

Rollock, George

- See also rent (4 October 1566).
- George Rollock, Master of the Almshouses, submits his accounts (22 January 1567).

Scottsgeir, John

- To be taken into custody until he pays John Gordon the money owed (26 February 1567).

Swine

- All swine to be removed from the area of the common gate and the wynds (4 October 1566).
