ADVICE TO APPLICANTS

Applications should be submitted along with:

- a signed copy of your Constitution
- a copy of your annual accounts for the last year or for new groups a projected budget.
- a short report on what your group has done in the last year and what you intend to do this coming year or for new groups a short report on what you plan to do.

All accounts must be presented to the Tenant Participation Officer for examination prior to submission of grant application.

You should estimate your costs for the coming year, on the basis of your expenditure in the last year. There is space on the form for you to explain why you think there might be any significant changes between one year and the next.

Your group may have funds left at the end of the year which have been earmarked for a certain piece of work such as a newsletter or a training event. If so, you should add a note to the application explaining this. Otherwise, the balance will be taken into account when considering how much grant your group is going to get.
