1.0 PURPOSE OF REPORT

The report details awards of up to £500 that have been made during the financial year 2011 - 2012 by the Community Safety Partnership

2.0 RECOMMENDATION

3.0 FINANCIAL IMPLICATIONS

- 3.1 The five grant awards totalling £2,297.50 have been met from the Community Safety Partnership funding allocated in 2011 - 2012.

4.0 MAIN TEXT

- 4.1 At the Policy and Resource Committee on 28 June 2001 (Report No: 71-2002) authority was given to the Dundee Community Safety Partnership to make small grant awards up to the value of £500.

- 4.2 The strategic priorities for the Partnership for the period involved were as follows:

- reduce crime (groups 1-4)
- feeling safer
- reduce wilful fire-raising
- community tension and counter terrorism
- prostitution
- home safety/accident prevention
- substance misuse
- partnership working
