#### 1. PURPOSE OF REPORT

To report to the Sub Committee on progress with the objectives, projects and reviews contained in the Council's strategic plans.

#### 2. **RECOMMENDATIONS**

It is recommended that the Sub Committee note the report and discuss any issues arising from the Exception Report which is introduced in section 9 below and detailed in the Appendices.

## 4. **BACKGROUND**

- 4.1 This is the latest quarterly report on progress with items in the Council's strategic plans, based on analysis of the assessments made in the Online Plan Monitoring Database.
- 4.2 A number of plans only recently approved by Committee are still in the process of being added to the database, which currently stores details of 1,343 plan items. All departmental plans should be included in time for the next quarterly report in June. Some other plans have only been very recently added to the database, which explains the number of items for which the first assessment of progress has not yet been made. Please note also that the database includes the action plans from Dundee's Community Plan for which the Council has overall responsibility, which explains why officers from partner organisations are shown as responsible for certain items.
- 4.3 As with previous quarterly reports, this report provides statistical information on all the plan items but focuses on those items which have been assessed as behind schedule, unlikely to be achieved or abandoned. These are detailed in the Appendices. A number of these items appear to be duplicated because the same plan item appears in more than one strategic document (e.g. both the Council Plan and a departmental Service Plan).

# 5. STRATEGIC PRIORITY ONE - CREATING AND DELIVERING A VISION FOR DUNDEE

5.1 There are 650 objectives, projects and reviews being monitored at present whose primary theme is one of the six Council Plan themes which relate to 'creating and delivering a vision for Dundee". Of those 650 the latest assessments are:-

- new services available through customer contact centres include disabled parking bay applications, free school meals/clothing grants, rent recovery agreements and blue badge applications

7.1 There are 168 objectives, projects and reviews being monitored at present whose primary theme is one of the six Council Plan themes which relate to "making best use of public resources in the city". Of these 168 the latest assessments are:-

- 7.2 Notable achievements to date include:-
  - updated option appraisal guidance issued to departments
  - Asset Management Plan approved, covering all the Council's operational property
  - Single Status Agreement on target for implementation in April
  - all planning consents and building warrants have been approved for Dundee House, and the design currently carries an 'excellent' rating for environmental and sustainability issues
  - business-related IT applications now replicated at a second data centre, enhancing business continuity
  - new financial management system, Authority Financials, installed
  - 18 staff now taking part in the home working pilot in Finance Revenues

#### 8. **OVERALL PERFORMANCE**

- 8.1 When the Online Plan Monitoring database was checked on 12 March 2008:
  - the total percentage of plan items which were completed, ahead of schedule or on schedule was 82.94%.
  - the total percentage of items which were behind schedule, unlikely to be achieved or abandoned was 5.67%
  - 11.39% of items had still to receive their first assessment of progress.
- 8.2 This is the first report produced since the new Council Plan and departmental Service Plans were approved. Future reports will include a comparison with the previous quarter so trends in the percentage figures set out in paragraphs 5.1, 6.1, 7.1 and 8.1 can be monitored.

- 9.2 There are a total of 84 items in the Appendices, some of which may appear more than once if the same commitment is made in more than one strategic plan. In most cases, the progress assessments give an explanation for why the plan item is behind schedule, unlikely to be achieved or abandoned, and many include revised targets or alternative ways in which the objective is being pursued. Please note that:
  - a number of items from the Dundee Community Plan, Sustainability Policy Action Plan and Equalities schemes appear not to have very recent updates. This is because the database is programmed to request updates for these items on dates which tie in with the reporting requirements for these particular plans. Items in the Council Plan and departmental Service Plans will receive quarterly updates, timed to give reports to the Sub Committee which are as up-to-date as possible
  - assessment dates for items which have been 'abandoned' may also appear older, as no further updates are requested once plan items have been given this status
  - a high proportion of the items included in the appendices are from the equalities schemes

#### 10. **POLICY IMPLICATIONS**

This report has been screened for any policy implications in respect of sustainability, strategic environmental assessment, anti-poverty, equality impact assessment and risk management. There are no major issues.
