1.0 PURPOSE OF REPORT

1.1 To seek approval for the Dundee Community Safety Partnership Commissioning Budget 2013-14.

2.0 **RECOMMENDATIONS**

3.0 FINANCIAL IMPLICATIONS

3.1 The amounts proposed within the allocation can be met from within the Dundee Community Safety Partnership commissioning budget of £41,253 for 2013-2014.

4.0 MAIN TEXT

- 4.1 The Dundee Community Safety Partnership commissioning budget normally comes to Committee together with the Strategy and Action Plan documentation for the current year. However, as the new Single Outcome Agreement for Dundee is currently being drafted and will not come to Committee until later in the year it has been agreed that the Community Safety Partnership strategy and action plan will be finalised within the same timescale as the Single Outcome Agreement to ensure consistency between the documents.
- 4.2 It is important, however, to ensure that the work of the Community Safety Partnership continues in the meantime and that resources are allocated to support the Community Safety Partnership priority areas and cross cutting themes which are:

- Impact of crime on individuals, communities and businesses
- Antisocial Behaviour
- Youth Disorder
- Violent Crime
- Sexual Offences
- Fire Safety
- Road Safety

Community Safety Partnership Cross Cutting Themes

- Personal Safety

- Public Protection
- Alcohol and Drugs
