#### **BACKGROUND TO THIS REPORT**

As from April 2013, the Police and Fire Reform (Scotland) Act 2012 has required Police Scotland to produce and publish a Local Policing Plan (LPP) for each local authority area. The LPP clearly sets out the policing priorities for Dundee.

Performance in relation to the identified policing priorities is monitored and reviewed internally on a weekly basis. Quarterly reports are produced to allow scrutiny by Dundee City Council Community Safety and Public Protection Committee. This report covers the period from 1<sup>st</sup> April 2017 to 31<sup>st</sup> March 2018, and from 1<sup>st</sup> April 2018 to 30<sup>th</sup> June 2018.

Data provided in this report is for information purposes to allow Board Members to conduct their scrutiny responsibilities.

This report will make reference to crime groupings. Groups 1-4 refer to an amalgamation of four crime groups. They are Group 1, consisting of violent crime; Group 2 covering sexual offences; Group 3 covers a wide range of crimes of dishonesty; and Group 4 includes vandalism, fire-raising and malicious mischief.

#### **EXECUTIVE SUMMARY REPORT**

This report brings to a conclusion the reporting year of 2017 to 2018 and highlights the good work that we continue to deliver whilst working with our partners across the City of Dundee.

The last 12 months have been significant in how we have policed the City and our continued focus on our Locality Policing model.

We have strengthened our partnership working across the city and utilised our community teams and National assets to their full ability.

The Locality Inspectors have embraced their areas, identifying local problems and working alongside our communities and partners to address these, which has given us a strong route to continue down.

We have developed and introduced a Divisional Prevention Hub working pan Tayside, to ensure best practice, learning and information sharing takes place. This remains at the early stages and there is a focus on deliverable outcomes across the city to provide education and prevention of crime at early stages.

There have been significant events held across the city which have involved a Police presence either being deployed at events or managing the increase in people around the city. This has brought a real vibrancy to all of those involved and we have seen Police officers and Partners engaging well with the public and ensuring our communities enjoy themselves and remain safe while doing so.

The year ahead will continue in the same theme, and there are numerous events planned which we have been involved in before and others new to the city, all of which bring their own challenges but that we remain committed to delivering safely and with a partnership and community approach.

This report provides the statistical data in relation to crime that has occurred over the course of the year.

Within page 3 of this report is an explanation of our crime groupings and details of Group 1-4 crimes, thereafter the report contains the statistics in relation to these crimes within Dundee.

There has been a slight increase in overall Group 1 crime, relation to 5% and ultimately 13 more victims compared to this time last year, however we have seen a reduction in Murder, Common Assault and Domestic Abuse incidents.

There has been an overall increase in Robbery which undoubtedly contributes to the rise in Group 1 crime, and as mentioned over the course of the year and within this

report there have been various different reviews into these crimes, which have identified there is no pattern or emerging trend and no repeat offenders or victims.

As we continue in to the new reporting year, we will work proactively and positively within Dundee. Our Officers will continue to be visible and approachable within their Localities in order to prevent crime and disorder as well as provide reassurance. Our City Centre Policing Team and Community Investigation Unit will be focussed on problem solving and working alongside our partners.

Moving forward Police Scotland will continue to work with partners around the Drugs Commission, in order to achieve successful outcomes.

# **Putting Victims at the Heart of What We Do**

Putting victims at the heart of what we do is a key focus within Dundee. By identifying it as a priority it allows us to focus on a victim centred approach to our response and preventative work.

Working with our partners and utilising all of Police Scotland's specialist resources and trained staff assists us in ensuring victims feel confident and supported in the service we are providing.

Throughout the year we have deployed Community officers across the city to engage with victims of crime, provide crime prevention advice and ensure safety measures are put in place for those who have unfortunately been victims of crime.

With the change in seasons during the last quarter and into the first quarter officers have been engaging with communities regarding doorstep crime and internet/telephone fraud as well as highlighting the risks posed with regards to leaving doors unlocked and windows open during the brighter evenings and warmer days.

A timer switch initiative was run and officers from Community teams engaged with Shelter housing to provide these to residents.

To address concerns regarding bullying at Schools across the city officers throughout these reporting periods have attended various Schools and provided in puts regarding antibullying and associated anti-social behaviour. This has focused on the affects that bullying causes and highlighting the impact on victims. In addition to this we continue to work and support our Schools to educate and eradicate such behaviour.

With this reporting period covering up until the School Summer holidays, the officers have been engaging with youngsters to ensure that this behaviour is identified and prevented which also lead to anti-social behaviour, of which we know causes significant concern in communities.

Continuing a victim centred approach Community officers from Maryfield identified a need to have translated versions of the National Media Campaign in relation to Sexual Offences. As a result they secured funding through partnership working and obtained posters and other associated material which was translated into various different languages to ensure that it reflected our communities, and vitally allowed victims information regarding support and reporting.

Work takes place daily across Dundee to identify Victims and to ensure their needs are met regarding safety and reassurance, officers will signpost victims to third sector organisations and ensure the Divisional Preventions hub and Community Safety Partnership are made aware of concerns and problems that can be addressed.

Between 21st and 25th May 2018, Community Police Officers in Dundee took part in Operation Monarda in conjunction with our partner agencies from Dundee City Council Trading Standards and Social Work, and Retail outlets and banks across the city. This

operation aimed at highlighting the dangers of bogus workmen and online fraud and offered advice to anyone who may be susceptible to this type of crime.

Throughout the week, Police Scotland and trading standards carried out days of action in the form of pop-up stalls at shopping centres, bingo halls, supermarkets and banks and handed out advice leaflets to customers as well as being a positive presence in the areas. Police Scotland also carried out area-targeted patrols in order to disrupt any possible crime of this nature.

Further to this, leaflet drops took place in conjunction with 'Meals on wheels' type organisations and some of these leaflets were also left with local pharmacies.

The aim was ultimately to increase the knowledge of the general public as well as creating a positive Police presence in specific locations

As we move into the next reporting period, we will see an influx in people across the city with major events taking place, including music events, parades through and across the city, the Open at Carnoustie which will involve officers from across Tayside, the opening of the new railway station encouraging more people to travel to the city and the V+A opening.

During all of these events officers will work hard to engage with communities putting victims at the heart of what we do and preventing and detecting crime.

### **Tackling Crime and ASB**

Tackling crime and Anti-Social Behavior is without a doubt a clear priority within the city. It is recognised that through early intervention and an early response we can prevent escalation and crime occurring.

Unfortunately during this reporting period there has been two Murders within Dundee. The first took place in January 2018 where by the male victim was assaulted in Albert Street, and succumbed to his injuries. Three males were arrested and charged with this offence and a detailed enquiry took place by officers from the Major Investigation Team (MIT). Community patrols were undertaken and reassurance provided in the local area.

The second Murder took place in May 2018, in Brown Constable Street, whereby a male was found deceased within an address, which resulted in a major enquiry again by the MIT and has subsequently resulted in a male being identified, charged and remanded in custody for this.

An Attempted Murder also took place in February, where a 32 year old male attacked a female in South Road, resulting in her losing her hand. The responsible male was quickly identified, traced and remanded in custody.

Operation Islington was launched in January 2018, to tackle anti-social behavior and violence across the city. This resulted in a partnership approach to tackle "party flats" in Dundee, with an appeal to members of the community to raise concerns and intelligence through the reporting mechanisms.

During the 3 month Operation period officers deployed with housing officers, wardens and members of the anti-social behavior team. Better links were made with local taxi companies to ensure safety messaging for drivers as well as intelligence gathering. Warnings were provided at addresses regarding tenancies and ASBO's resulting in a reduction in noise complaint calls. A media campaign was launched and positive feedback was gained from partners.

A defined process has now been implemented through our local Proactive Policing Plan and in conjunction with the preventions hub to identify problematic areas or individuals and a pathway of escalation in order to tackle them.

Work has been ongoing in the Maryfield ward to reduce crime and tackle ASB, and as a result of joint working CCTV cameras have been approved and installed to cover the entire length of Dundonald Street.

Tackling drugs and associated crime remains a priority and Tayside Division launched Operation Slate some years ago to capture this activity.

There has been significant activity carried out by the Community Investigation unit over the last two quarters in this area with some of the results as follow:

In February a male was seen acting suspiciously in the city center, he was searched and found to be in possession of £11,500, a search of his address recovered £3000 worth of heroin.

Again in February a vehicle was stopped near to the Swallow roundabout, a search was conducted and £30,000 worth of heroin was recovered. Those responsible were arrested and charged.

In March a search warrant was executed at an address in Coldside and over £5000 worth of valium tablets were recovered.

In April a search warrant was executed at an address in Lochee, whereby £25,000 worth of Cocaine was recovered. The male responsible was arrested and charged.

In May three males were arrested for possession of over £4500 of Cocaine from an address in Broughty Ferry.

A further operation in May, resulted in £22,500 of heroin and £1700 of cocaine being recovered from two addresses in the Charleston area.

A vehicle was stopped in the Coldside area and 3.3kg of cannabis was recovered, worth £14000, a 32 year old male was arrested and charged.

In June £109,000 worth of heroin was recovered from an address in Maryfield. Also in June 256g of heroin were recovered from an address in Lochee.

There has also been some significant arrests during both reporting periods regarding acquisitive crime.

In March a 37 year old male was identified for a house breaking in The East End, he was arrested and charged.

Also in March a 38 year old male was identified as being responsible for 3 House breakings to Clarks Bakery, Golden Start Takeaway and an address in Commercial Street.

A 32 year old male and a 34 year old female were responsible for two House Breakings in the Maryfield area, they were traced and arrested.

In April there was a series of House Breakings to takeaway restaurants, 4 across the city, a 26 year old male was identified as being responsible.

In June a 27 year old male was identified and charged with a series of crimes including three House Breakings, Vandalism and Theft.

Again during these reporting periods there have been a couple of significant fires. The first being

A Fireraising at Faztech LTD occurred in February, which resulted in significant damage to the warehouse and thousands of pounds worth of damage being caused. A 28 year old man and 40 year old man have been charged with various offences linked to this.

In April a Fireraising occurred at the derelict building site of the former Baldragon Academy, a joint response took place and an investigation was undertaken resulting in a 15 year old male being reported to the Procurator Fiscal.

Officers have deployed on bicycles in conjunction with wardens, and ASB team to conduct high visibility patrols around areas affected to provide reassurance and gather intelligence.

An incident also occurred in May whereby a male was responsible for attacking two members of the public in the area of Caird Park, one of whom he used a chainsaw on. The injuries caused were serious however not life threatening. A significant Police response supported by colleagues from the Criminal Investigation Department resulted in a 44 year old male being arrested and charged with Assault and other offences.

Looking forward to the next reporting period, officers will continue to undertake proactive and high visibility patrols across the city to prevent incidents from happening and or be in a position to respond quickly.

Operation Dundee Safe continues to run during the weekend and nighttime economy, seeing significant engagement with licensed premises and members of the public out in the city, which allows early intervention and prevention.

Officers from the division will also be taken to make up a small dedicated Robbery team focused solely on this crime type, linked into the Divisional action plan they will assist with ongoing investigations and early intervention. As mentioned previously there has been no link or trends to these crime types, however work will take place with the preventions hub to ascertain what additional support and prevention can be put in place to prevent these incidents occurring.

### **Protecting Vulnerable People**

It is vitally important that in Dundee we work with our communities and partners to ensure that vulnerable people are protected. Our community teams remain instrumental to this as does our partnership working through the Community Safety Hub, and its current and revised structure. We ensure that vulnerability is identified and the appropriate mitigation and support is put in place.

During this reporting period community officers have been providing safety talks to numerous vulnerable groups within our community. This includes home and personal safety talks to the elderly, internet safety to youth groups and participating in numerous school inputs from Primary 1 to Secondary 6 year groups.

Maryfield Community Officers worked closely with vulnerable young adults who were chosen as candidates for Princes Trust in an effort to guide and encourage moral compass. The princess trust continues to run very well and has just finished delivering another program which has without doubt provided youngsters additional support and guidance during a time where they have some focus and direction.

It was also identified that some of our community are vulnerable due to language barriers and a lack of understanding of Law. As a result funding was also sought by community officers to translate police documents to raise awareness of governance / legislation under Scots Law in 9 minority languages. These have been distributed within the local Maryfield community with success, and there are plans to have this practice shared across the city.

Working with Add-Action, two local reformed drug users have agreed to work with local community police officers and talk to groups of youths within schools about the 'real' issues relating to participating in drug abuse and the impact it can have upon lives. This partnership is also making a linked video/media campaign for community safety about drug abuse and drug litter in communities which will be released in due course.

There are conversations ongoing regarding a pilot scheme of RAPID (Response All Prescriptions and Illegal drugs) this has been successfully deployed in Northern Ireland and in essence are disposal bins located at prominent places to encourage people to discard these drugs. Talks are at an early stage and as a partnership these will be discussed at the ADP strategic partnership group in due course.

Monthly meetings, information days and local visits have taken place by Community officers to Syrian families in the city, providing reassurance, safety advice, legal differences and contacts for crime reporting as well as signposting for support organisations.

Joint warden and Police patrols have taken place across the city to educate parents dropping off and picking up children from School which have been run in conjunction with schools. This will continue to develop in the next reporting period and will also see the roll out of the Go Safe program which will include invites for walks to school, with various partners, department heads and elected members.

This reporting period has also seen the launch of the Trauma Teddies initiative from the Longhaugh Community officers. This initiative has gained great momentum and has had a fantastic response from the local community, with 500 teddies being donated.

The concept being that Police officers can issue hand knitted teddies to young persons who have either been a victim or witness in situations such as road traffic collisions, missing, domestic incidents or criminal offences and that this provides comfort and helps break down barriers. The teddy is also provide with details as to how Children first can be contacted for support.

Officers have been working with Scottish Charity Children  $\mathbf{1}^{\text{st}}$  in order to launch this appeal which has gained National momentum with the process being shared across all Policing Divisions in Scotland.

### **Maintaining Public Safety**

Ensuring that our Communities within and the people who visit Dundee are safe is a primary focus for us. The Locality Inspectors and Community Policing Teams have a pride in their areas and have a drive and dedication towards maintaining public safety.

Repeat Callers are managed closely and focus on early intervention to improve the wellbeing and safety of those within our community. Effective relationships with our community partners is key to this success and officers have managed to successfully resolved approximately thirty Repeat Callers in one Locality during the last 12 month period.

Effective community consultation and pop up information stalls by all the community teams has assisted in safety awareness raising and sharing appropriate intelligence. Officers will continue to undertake this community engagement to build trust and confidence, as well as alleviating the fear of crime.

The introduction of 'Coffee with a Cop' events with a local/community emphasis has encouraged open conversations with Maryfield Community Officers and the community without having a formal agenda. This arrangement has allowed for honest conversations to be had in a more relaxed environment where local communities are more likely to attend and engage with police. These will continue to be held and our communities encouraged to utilize them.

'Go Safe Dundee' is an initiative driven by Maryfield Community Officers along with Parent Council Members to improve safe parking outside schools in Dundee. A £3000 budget has been given by DCC and the next school term will start with some hard hitting campaigning directed towards irresponsible and dangerous parking outside schools.

Also in these reporting periods funding was successfully sought and cycle lights were obtained to promote safer cycling in the local community, during the darker evenings.

Inputs have continued at Schools regarding knife crime, drugs and bullying and the mentors against violence scheme remains pertinent and worthwhile, this will continue into the next reporting period and will be a focus when the schools return from their summer break.

In May, the Justice Secretary, Michael Matheson visited Braeview Academy in relation to the No Knives better lives campaign, this was the last secondary school in the city to have the delivery for the 2017/2018 term, and received positive and supportive feedback from the Justice Secretary. The campaign will begin in August for the next term and will continue to be peer led and supported by the Police Scotland Youth Volunteers.

Road safety initiatives continued during bad weather with officers carrying out safety checks at designated points across the city and providing advice and guidance about driving in difficult conditions and being winter ready.

Special constable recruitment events have continued at pop up events, summer fairs and fun days. Continuing to highlight the role of the Police and the significant difference and contribution special constables make.

Moving forward there are further Bluebell tea's planned for officers to engage with community members, provide safety messaging and build strong relationships. These also help break down barriers and have been used successfully where there have been issues around ASB.

The Safe Place initiative has also been launched and is about highlighting specific places across the city where vulnerable members of the community that require support can attend if requiring support or are in crisis. At the safe place they will find somebody who has been trained to allow assistance and signposting to take place. Community officers will be involved in this throughout the city with support from the preventions hub.
