1.0 PURPOSE OF REPORT

1.1 To submit to the committee a request for grant funding for Generator Projects.

2.0 RECOMMENDATIONS

2.1 That the Committee approves support of £7,000 for Generator.

3.0 FINANCIAL IMPLICATIONS

3.1 The grant of £7,000 can be met from the Leisure and Communities revenue budget 2008/09.

4.0 MAIN TEXT

4.1 Reference is made to Article I of the minute of the Leisure and Arts Committee dated 17 May 2004 when funding of £7,000 was granted to the Generator Project.

Generator Projects is a non profit visual arts organisation run by a voluntary committee of professional artists and is supported by a membership of over 300 local artists. The organisation presents innovative contemporary art by emerging visual artists and curators through an extensive exhibitions and events programme. The committee works closely with other local arts organisations including Dundee Contemporary Arts, University of Dundee and Dundee City Council Arts and Heritage Team to develop support and opportunities for professional artists in Dundee.

The Leisure and Communities Department's Creative Learning Team offer the Generator Project's committee and membership support through professional development and cultural networking events, employment and training opportunities. The Creative Learning Officer also provides a supporting role to the organisation by having a place on the Generator Project's advisory board. A former Chairperson of the organisation also sits on the panel of the Dundee Visual Artists Award Scheme, administered by the Creative Learning Team.

4.2 Alongside the visual arts programme, the committee works closely with local arts organisations and professionals to extend the network of support for artists in Dundee. In 2007 this centred on 'Your Words and My Mouth' a two-day exhibition and live arts event held at Hospitalfield House, Arbroath on 22 and 23 September. This project was a curatorial collaboration between Dundee Contemporary Arts, University of Dundee Exhibitions Department, Generator Projects, Bad Bad Boys Club and Hospitalfield House and is the first large-scale collaboration between these Dundee-based curators.
