Dundee Community Safety Partnership continues to be highly regarded nationally and staff from our various partner agencies are representing our interests in various national forms.

It is testament to the hard work and innovative approaches by partners within the current financial climate that we see the continuation of the downward trend of the last six years and that further reductions are reported in:

- Shoplifting
- > Theft
- > Domestic dwelling housebreaking
- Drug offences
- Serious assaults

The minute of the above meeting was approved.

II CO-CHAIRPERSON'S REPORT

Neil Gunn, Co-Chair, welcomed everyone to the Annual General Meeting stating that it had been another very successful year for the Partnership and outlined the following key points:-

(i) KEY ACHIEVEMENTS

11% reduction in recorded crime.

25% reduction in serious assaults and robberies.

34% reduction in people charged with carrying offensive weapons.

29% reduction in youths causing annoyance calls.

11% reduction in vandalism.

11% increase in those perceiving crime as decreased in their neighbourhoods. Reduction in secondary fires - particularly on bonfire night.

These groups are running and it is thanks to the input from the people on these groups that the DCSP has had the success it has had over the last twelve months.

(iv) DCSP MEETINGS

- Good turnouts at all meetings
- Covered a really interesting range of topics -Counter terrorism, prostitution, drugs/alcohol, child protection, road safety, fire raising and youth diversionary activities.

III PRESENTATION OF ACCOUNTS 2010-2011

(i) FUNDING REPORTS - SMALL GRANTS

It was noted that various initiatives had been able to be supported such as Dundee Voluntary Action, CYPPC/CSP Peer Education, St Mary's and Brackens Community Safety Group, Violence Against Women Partnership, Peer Education Project, DCC Education Department and Mid Lin News Group.

(ii) LOCAL ACTION FUND

Members noted the Diversionary works which had been supported throughout the City. It was re-iterated that any underspends require to be reported immediately so funds can be reallocated and feedback was requested by October, 2010.

(iii) COMMUNITY SAFETY PARTNERSHIP AWARDS

A number of initiatives had been able to be supported i.e. Hilltown Music Project, Youth Mobile Resource Unit, The Shore Diversionary Youth Work and East, West and Central Diversionary Youth Work.

Thereafter the Partnership approved the accounts as submitted.

IV PERFORMANCE REPORT - CRIME STATISTICS FIVE YEAR TRENDS

The following points were noted from the presentation by Gavin Robertson, Tayside Police and Co-Chair of the Partnership:-

- Highlighted contribution of DUNCAN, BEST BAR NONE and Dundee Licensing Forum
- Multi-Agency Assessment Team Deal effectively with crimes of a sexual nature
- Domestic Abuse Allegations treated as seriously as other crimes
- Vandalism downward trend
- LCPP'S Communities more proactive
- DCC Graffiti Project
- Relevant enquiry procedure adopted by Tayside Police
- Youth related calls downward trend
- Mobile Resource Vehicle has to be justified
- Secondary fires dealt with through partnership working, Education and Fire Related Issues Sub-Group
- Domestic Dwelling Homebreaking major priority
- Publication of Crime Prevention Booklet
- High re-offending rates in Dundee
- Shoplifting Upward trend (Organised Crime)

Gavin was thanked for his presentation and re-iterated that the Partnership was working well.

V DUNDEE COMMUNITY SAFETY PARTNERSHIP REPORTS

(i) DUNDEE VIOLENCE AGAINST WOMEN PARTNERSHIP

(ii) YOUTH INTERVENTION GROUP

The following was noted relative to the above:-

Helping to reduce youth crime;

- % charged with a crime had fallen sharply;
- Attention to "Hot Spot" areas shops, parks, etc;
- Methods of working, i.e. engagement in the community;
- Lack of access to PPP schools.

(iii) TECHNOLOGY SAFETY GROUP

It was noted that there was good partnership working within this group and that an action plan was being formulated.

Work had been undertaken in primary schools and Tayside Police has been working with secondary schools with emphasis on how new technology affects young people's lives and how they should use it safely and securely.

(iv) FIRE RELATED ANTI-SOCIAL BEHAVIOUR GROUP

It was noted that this group had been running for a number of years and meets monthly, with a lot of information sharing taking place. There had been almost one thousand less fires over the last four years and this was a notable achievement.

Day camps for those with issues around fire raising are held at Kingsway Fire Station. With regard to home fire safety outcomes, a report had been submitted to Tayside Fire and Rescue Management which showed that the outcome target of 11,000 visits for 2009-2010 had been achieved. Of the 11,100 visits undertaken 6,000 were in Dundee, where 60% were in areas where risk of fire deaths remained constant.

(v) HOME SAFETY GROUP/SAFE TAYSIDERS

It was reported that a lot of collective work had been undertaken by the Home Safety Group and Safe Taysiders. A lot of multi-agency working had taken place in relation to Safe Taysiders.

The Home Safety Group were rolling out a programme providing smoke alarms to deaf people and a seminar had been arranged targeting bogus callers, junk mail, e-mail and cold calls.

(vi) ROAD SAFETY FORUM

The Road Safety Forum had been set up to review road safety overall in Dundee. To measure the success of this group specific targets would be met over the period 2010-2020. The forum meets quarterly and have considered terms of reference, target priorities and membership.

Ongoing work includes education, enforcement and a "Safe Drive - Stay Alive" programme to be targeted at S5 pupils.

(vii) COMMUNITY SAFETY NETWORK

It was reported that Voluntary and Community Organisations had been involved in promoting personal security etc and people were generally happier with the communities they live in.

Work was ongoing to increase and improve community partnership.

(viii) STRATEGIC INFORMATION MONITORING AND EVALUATION GROUP

The group are responsible for collating information and are working towards provision of more cohesive information, information management and a monitoring framework.

VI DUNDEE COMMUNITY SAFETY PARTNERSHIP STRATEGIC ASSESSMENT

The Strategic Assessment for the Dundee Community Safety Partnership provided an analytical overview that allowed evaluation of the community safety issues and identified priority areas across Dundee. The strategic assessment takes into consideration Policing priorities, the local and Scottish Government objectives and Single Outcome Agreement, and the Community Safety Partner's priorities.

The strategic assessment aims to provide an accurate picture of current and emerging trends which would allow the partnership to effectively direct resources based on the needs identified. By identifying and prioritising key areas that have a significant impact upon communities throughout Dundee it would provide strategic direction for the partnership.

A total of £131,581 was seized in 25 separate cases

Reduction in availability of controlled drugs - difficult to measure

Central Division Crime Management recorded that 151 drug search warrants were executed.

Drugs branch executed 282 warrants - but not all specific to Central Division

Raise number of child referrals re drug abuse

There were 4,421 child concerns reports submitted this year

Approximately 200 have a drug related marker -however this is not necessarily due to drug abuse by the child

Reduce number of drug overdoses

There were 109 heroin overdoses recorded on CAPTOR, 17 were fatal during 1/4/2010 - 31/03/2011

Co-ordinated and intensive tackling of drug issues in areas where Community Engagement Team is deployed based on intelligence

The Community Engagement Team has been deployed in Lochee and Hilltown area where it has tackled on and off street drug dealing. This has also involved visiting areas where dealing is ongoing and drug litter is a problem. Needles are uplifted, posters put up and ditch a dealer leaflets distributed

Increase detection rates

There were 171 cases of drug dealing detected
There were 1056 cases of possession of drugs made known

To support the work of Dundee Violence Against Women Partnership in tackling domestic abuse, sexual violence and prostitution.

The Dundee Violence Against Women Partnership is a multi-agency group working to tackle all forms of violence against women. Working in partnership with organisations, communities and individuals across Dundee we strive to raise awareness of violence against women and facilitate the development of approaches that support women, children and young people, challenge perpetrators and work towards the prevention of violence against women over the long-term.

The Violence Against Women Partnership represents violence against women issues at Community Safety meetings. We represent agencies from across the statutory and voluntary sector, including specialist violence against women services.

Outputs Delivered

There has been a year on year increase in the number of women, children and young people affected by violence against women engaging with appropriate support services. This includes the introduction of new services for women involved in street prostitution.

Enforcement activity in relation to perpetrators is led by Tayside Police. This would cover any policing activity relating to perpetrators of domestic abuse and sexual offences, kerb crawlers, those involved in crimes associated with trafficking etc. Enforcement activity is part of Tayside Police's day to day operational activity, but there have been specific additional initiatives/periods of action in relation to kerb-crawlers and in relation to perpetrators of domestic abuse. For example, Operation Linchpin II took place in December 2010/January 2011 focussing on perpetrators of domestic abuse (building on Lynchpin I that took place over the same period in 2009/2010).

Tayside Police have continued to address community concerns regarding prostitution. This has included the enforcement activity outlined above in relation to kerb crawlers. resources have also been invested in responding to individual complainers and supporting them to access other advice and information services.

Outcomes Achieved

There continues to be a good level of multi agency commitment to addressing prostitution issues in Dundee. Tayside Police have shown particular commitment to working in partnership with Women's Rape and Sexual Abuse Centre (WRASAC) to address the needs of women involved in prostitution. Dundee City Council have recently invested further funding in the Vice Versa service to sustain this for the 2011/2012 period and referral sources for the service continue to widen beyond core police referrals.

New care pathways for drug treatment services for women involved in prostitution have been agreed through the Alcohol Drug Partnership. These are currently being implemented and will require to be monitored throughout 2011/2012 to ensure they are effective.

The commitment to multi agency working to address the needs of women involved in prostitution has resulted in a number of women making significant positive changes (see below)

Supporting Evidence

- there was a 30% decrease in the number of males charged with soliciting services of a person engaged in prostitution in comparison to 2009/2010
- A decrease in the number of sexual offences that were detected (fall from 78% in 2009/2010 to 70% in 2010/2011)
- An increase in the number of sexual offences that were detected which were reported to the Procurator Fiscal (72% in 2009/2010 to 83% in 2010/2011)

For the period 2010/2011 the Women's Rape and Sexual Abuse Centre reports

- 41% increase in number of new women engaging with WRASAC services in comparison with 2009/2010
- 37% increase in the total number of women engaged over the year in comparison to 2009/2010
- > 82% increase in the number of support sessions offered in comparison to 2009/2010, with a 176% increase in the number delivered/completed

For the period 1 April 2010 - 31 December 2010 Dundee Women's Aid reports

- > 8% increase in the number of women accessing DWA core services in comparison with the same period in 2009
- > 12% increase in the number of children and young people accessing DWA services in comparison with the same period in 2009


























Single Outcome Agreement Annual Report 2010/11 - Community Safety Theme

Dundee Community Safety Partnership manages the Community Safety Theme on behalf of the Dundee Partnership, Building Stronger Communities Group. In particular, the Community Safety Partnership has responsibility for Dundee Outcome 7 - Our communities will be safe and feel safe.

Indicators: Progress and Conclusion

> Reduce Crime (Group 1 - 4)

The target was to reduce the three year average from a baseline of 12,029 to 11,066 by 2011.

We have exceeded this target and reached a figure of 10,378 for the three year average.

Increase % of those who state that fear of crime has no effect on their quality of life (Dundee City Council Annual Consumer Survey)

Dundee Community Safety Partnership does not use the Dundee City Council Annual Consumer Survey as it has very limited Community Safety related questions included. The Community Safety Partnership uses the Police Public Perception Survey and the following questions are asked:

- Does fear of crime prevent you taking part in everyday activities?
 - 92.5% respondents said No
- How safe do you feel walking alone during the day? After dark?
 - 91.5% respondents said either very or fairly during the day 45.7% respondents said either very or fairly after dark
- To what extent do you agree Police, Council and partners are dealing with Antisocial Behaviour and Crime Issues that matter in your neighbourhood?
 - 62.5% respondents said either strongly or tend to agree
- Taking everything into account, how do you rate your neighbourhood as a place to live?
 - 80.7% respondents said either very or fairly safe

These are improved figure on last year.

Intermediate Outcomes

Dundee has reduced levels of crime

As testament to the hard work and innovative approaches by partners within the current financial climate we have seen a continuation of the downward trend of the last six years with further reductions reported in :

- Youth related calls
- Shop lifting
- Theft
- Domestic dwelling housebreaking
- Drug offences
- Serious assaults
- Motorcycle nuisance calls
- Secondary fires

> Dundee has reduced fear of crime

As described earlier, figures based on the Police Public Perception Survey show improvements on the relevant questions.

It is evident that statistically our communities are safer than they have been and that the continued downward trend of the last six years in the number of offences is a welcome one. What is particularly welcome is the fact that people's perception of crime and fear of crime are improving. In welcoming the continuation of these trends, however, this is a recognition that all partners need to not only continue their previous efforts but continue to build on them.

NARRATIVE

i. What have we achieved?

Against all odds, we have continued to show reductions in crime over a sustained period of six years and to show that the impact of the fear of crime on people's lives is reducing. The Community Safety Partnership has continued to evolve and further develop its strong ethos of effective partnership working typified by a genuine desire and commitment to ensure resources are maximised effectively. Key to our success is in our ability to target resources on an intelligence led basis and to ensure that appropriate partners lead on specific issues with other partners contributing as required/requested by the lead. There are now over 20 partner organisations contributing to the overall intelligence picture allowing the Community Safety Partnership to have a truly partnership strategic assessment document and effective monthly and quarterly tactical documents informing partner input.

ii. What challenges are we facing?

Inevitably, the Community Safety Partnership is facing the same challenges as other public sector operations i.e. financial and organisational downsizing. It is difficult to predict the extent of the impact this will have but it has the potential to be significant. The impact of the recession on crime statistics may still yet manifest itself adversely and with fewer resources, the ability to continue the downward trend of the last six

years may well be compromised. The challenge to continue to reduce therefore, will be significant and we may well find ourselves working hard to sustain current levels.

iii. How will we achieve more?

The Community Safety Partnership is committed to continuing to improve its operational effectiveness. A move towards co-location of appropriate partners would assist this significantly if suitable premises can be found. This will assist partners to pursue their strategy of pro-active interventions at an early stage in any given situation which has proved to be successful over the last six years. Integral to the success of this strategy has been our ability to reserve enforcement as a last resort, preferring instead to encourage those involved to work with partners to achieve a successful outcome.

CASE STUDIES

Graffiti Group

A sub group was formed to tackle the increasing levels of high profile graffiti in the City. This was highlighted in particular by the high numbers of HARM and RESM tags across the City. The sub group is chaired y the Community Safety Warden Coordinator and includes representatives of what was Waste Management, Environmental Health and Trading Standards, Social Work, Community Payback and Police.

Intelligence on graffiti across the City is collected by partners, photographed and is collated by the Community Intelligence Unit. Work is undertaken to identify the perpetrators of these acts and action is taken to ensure that they are held to account for this.

A pilot was undertaken to select an area particularly badly affected by graffiti and target resourced over a concentrated time period to "blitz" the area. Partners identified Strathmartine Road as the first pilot area. Offenders on Community Payback Orders were concentrated on the area as was staff from the various Council departments who were able to use more potent chemicals. The Community Safety Partnership also commissioned monies to purchase paint for the purpose to be used by those on Community Payback Orders.

In addition, where the graffiti was on private property, Community Safety Wardens visited and encouraged owners to participate in the scheme by taking responsibility to either remove the graffiti or contribute to the overall scheme.

Due to the success of this initiative the next area to be tackled will be the City Centre. Some of the Community Safety Partnership commissioning monies may also be used to hire cherry picker vehicles to allow access to harder to reach graffiti.
