1 PURPOSE OF REPORT

1.1 To seek Committee approval for the acceptance of the recommended tender for smartcard readers on behalf of the National Entitlement Card programme.

6 MAIN TEXT

6.1 The Scottish Executive's Customer First programme is managed by the service delivery arm of the Improvement Service. Dundee City Council acts as the lead agency for the Entitlement Card element of the scheme and is fully

funded to manage the scheme on behalf of the Scottish Executive, Scottish Councils and other public sector bodies.

- 6.2 This procurement is intended to establish an agreement to enable the call off of smart card readers / writers by Councils over the next 2 years.
- **6.3** Six companies responded to the Invitation to Tender, details as follows:
