1 PURPOSE OF REPORT

1.1 To advise Committee on an allocation to Dundee City Council from the Scottish Executive's Financial Inclusion Fund, and to report on tenders returned from research and strategy development companies for the production of a Financial Inclusion Action Plan for Dundee

2 **RECOMMENDATIONS**

2.1 It is recommended that Insight Collective Ltd be appointed to carry out the Financial Inclusion Action Plan development as required by the Scottish Executive.

3 FINANCIAL IMPLICATIONS

3.1 The cost of the contract will be £25,774 to be met from transitional funding which has been allocated to Dundee City Council in support of the Financial Inclusion Fund by the Scottish Executive

5 **EQUAL OPPORTUNITIES IMPLICATIONS**

5.1 The proposals contained in this report will tackle the causes and effects of financial exclusion and challenge levels of poverty experienced by significant numbers of families and individuals in Dundee.

6 BACKGROUND

- In June 2005, the Scottish Executive launched the Financial Inclusion Action Plan and with it, £10m of extra resources targeted to local authorities with the greatest concentration of financial exclusion. Dundee with 12.9% of households without bank accounts or savings, and 19.7% of the population income deprived, has been allocated £450k in each of the years 2006/7 and 2007/8.
- 6.2 It is anticipated that the Fund will be used to provide services to communities which might include:
 - building financial capability/prevention/education into all relevant services
 - new types of services likely to involve more than one organisation or activity and promoting affordable lending, community banking approaches etc
 - promoting further examples of partnership working that include the private and social economy sectors
- Plans for using the allocation from the Financial Inclusion Fund are to be agreed with the Scottish Executive by Christmas 2005. To assist in preparing plans, the Scottish Executive awarded £50,000 of transitional funding. In consultation with Community

Planning partners within the Anti Poverty and Social Inclusion sub-group of the Dundee Partnership, it was agreed to appoint a consultancy to develop the plan for Dundee.

- 6.4 A detailed brief was issued to four research and strategic development companies. The brief outlined four essential elements
 - a) a baseline analysis of financial exclusion in Dundee
 - b) an audit of existing financial services
 - c) development of a Financial Inclusion Action Plan
 - d) the identification of performance indicators and targets for the purposes of monitoring and evaluation
- 6.5 The tenders received were as follows:

Insight Collective £25,774

- * This figure has been amended using information provided which allows for comparison based on 'like for like' delivery of project activities.
- 6.5 Taking into account cost, professional expertise, proposed methodology and quality of activity in terms of stakeholder interviews and baseline survey sample sizes, it is recommended that the contract be awarded to Insight Collective Ltd. While Blake Stevenson submitted the lowest tender, its proposal did not include a baseline study of financial exclusion as required by the project brief.
