MAIN TEXT

Detailed information relating to the above Tenders is included on the attached sheets.

The tender for loose furniture and equipment covers items such as: pupil desks/chairs, office/teachers' desks/chairs, tables, storage units and other necessary equipment identified through consultation with members of the school staff and NHS Tayside.

It should be noted that the existing furniture/equipment was the subject of a condition audit and where deemed acceptable will be transferred and reused in the new school. However, as this is a new school, and in line with the procedures followed in the other completed schools, it was agreed that all standard furniture for pupil use would be new. Specialist furniture for individual pupils will be transferred to the new school.

Given the competitive nature of the tender for the provision of the Loose Furniture and Equipment and taking account of the specialist nature of some of the furniture required to facilitate flexibility for the pupils attending Kingspark School it was deemed prudent to provide a realistic allowance for the miscellaneous items of furniture that are unable to be identified at this stage in the process. It was also deemed prudent to set aside a contingency on the total estimated spend to allow for unexpected requirements as they arise and for likely increases in costs such as delivery, increase in steel price etc. on items that are not part of the main tender.

The report identifies allowances for a number of services/equipment etc. The allowances stated are estimates based on the experience gained from the recent school building projects and have been set to reflect a realistic expectation of the costs associated with providing the service/equipment listed.

Where required under standing orders reports on the additional items listed in the allowances section will be made to Committee once firm prices are obtained.
