1.0 PURPOSE OF REPORT

1.1 The purpose of this report is to advise Committee on the disbursement of Dundee Community Safety Partnership funding which has received Scottish Government consent to carry forward from 2007-2008.

2.0 **RECOMMENDATION**

2.1 It is recommended that the Committee note the disbursement of seven commissioned services which fall within the strategic assessment for the Dundee Community Safety Partnership in 2008-2009 (see Appendix 1).

3.0 FINANCIAL IMPLICATIONS

3.1 These seven awards totalling £52,709 can be funded from the 2007-2008 carry forward consents of £80,462 from the Scottish Government.

4.0 MAIN TEXT

- 4.1 Due to the lower costs involved in delivering major commissioned services by the Partnership during the financial year to 31 March 2008 consent was requested and received from the Scottish Government to apply the underspend accruing from 2007-2008 to initiatives which help to tackle or reduce identified community safety work of the Partnership in 2008-2009.
- 4.2 All partners were invited to bring forward proposals for funding allocation and the initiatives outlined in the Appendix have been approved in principle by the Partnership subject to the production, agreement and monitoring of agreed outcomes.

This work is well advanced.

4.3 The initiatives referred to under Para 4.1 have been evaluated and reported under the Dundee Community Safety Partnership Annual Report 2007-2008 noted by Committee under Report No 437-2008 on 21 August 2008.

5.0 POLICY IMPLICATIONS

5.1 The report has been screened for any policy implications in respect of Sustainability, Strategic, Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.
