#### 1 PURPOSE OF REPORT

1.1 To gain Committee approval for the next phase of energy efficiency projects as part of the 2020/21 Capital Programme.

#### 2 **RECOMMENDATION**

## 4 MAIN TEXT

4.1 As these properties are all fully tenanted, the client contribution for the 26 properties for EWI will be required from the HRA Capital budget 2020/21. Addresses included in this project:

Magdalene Kirkton 3<sup>rd</sup> Swedish Timber properties 1, 9, 13, 15, 17, 21, 23, 25, 27 Helmsdale Drive 10, 12, 20, 24, 26, 30, 32, 34, 40, 42, 44, 48 Helmsdale Drive 4, 12, 18, 22, 24 Helmsdale Place

The works include a bespoke external wall Insulation system that will be applied by utilising a rail system attached to the existing external timber façade.

4.2 Resources are available to fund external insulation for Council owned properties within the current 5 year HRA Capital budget.

4.3 Funding will contribute to the on-going delivery of the energy efficiency programme. The Contractors for these works have been procured by SSE who are project managing the programme on behalf of the Council. The project is due to complete by 31<sup>st</sup> May 2020.
