1.0 PURPOSE OF REPORT

1.1 To inform the Policy & Resources Committee of the savings proposed for financial year 2019/20 regarding the provision of Kick It Kick Off (KIKO) within Children and Families Service.

2.0 **RECOMMENDATIONS**

2.1 It is recommended that the proposed savings described in this report is considered by the Policy & Resources Committee as potential savings in financial year 2019/20.

3.0 FINANCIAL IMPLICATIONS

3.1 The implementation of the following proposal would result in part year estimated savings amounting to £109,000 in financial year 2019-20 and full year savings of £174,000 in 2020/21.

4.0 MAIN TEXT

- 4.1 There is an imperative to identify and achieve significant savings in financial year 2018/19
- 4.2 KIKO (Kick It Kick Off) is an outreach project which uses a football programme with S1 and S2 pupils who are disengaged from school. The programme is not a mandatory service and is one which complements other aspects of learning and achievement within a flexible learning plan for young people.
- 4.3 The KIKO team consists of 5 FTE staff although only 3 are currently in post, with one additional post funded by PEF. All staff would need to be redeployed should KIKO not continue. Two staff have permanent posts, and two have temporary posts, one of which is funded by PEF.
- 4.4 Recent developments with initiatives such as Breakthrough Dundee, which now works with young people in all of our secondary schools, including the Rockwell Learning Centre, are now providing a significant level of pastoral support for young people in danger of school disengagement. In addition to this schools are developing a range of alternative curriculum programmes which incorporate skills development in outdoor and leisure/sports settings, and have options to use other sources of funding.
