1. **PURPOSE OF REPORT**

1.1 This report outlines the revised Child Poverty Strategy for Scotland, highlights progress on the actions which respond to this in the Dundee Fairness Action Plan and recommends further activity to add to the action plan.

2. **RECOMMENDATIONS**

- 2.1 It is recommended that Committee:
 - a) notes the progress made on the Fairness Action Plan;
 - b) approves the additional items outlined in para 6.3
 - c) approves the formation of a Fairness Commission for Dundee and instructs the Chief Executive to bring forward recommendations on a remit and membership to a future meeting of the Policy and Resources Committee

3. FINANCIAL IMPLICATIONS

3.1 There are no new additional financial commitments contained in this report.

4. BACKGROUND

- 4.1 The Dundee Partnership and Dundee City Council adopted the Dundee Fairness Strategy and action plan in June 2012 and updates have subsequently been reported to Committee.
- 4.2 The extent and impact of poverty in Dundee and Scotland have continued to increase since June 2012. Local analysis indicates that this is mainly due to the still recovering economy, shortfalls in family income due to the cumulative impact of low pay and the huge impact of the UK Government's welfare reform programme. In April 2014, the Joseph Rowntree Foundation reported that social housing tenants are particularly hard hit by welfare reform; the benefits system is becoming tougher and tighter, with more sanctions, reclassifications, exclusions and suspension of payments; food banks are becoming essential; and people are experiencing high energy bills and debt.
- 4.3 Dundee's pro-active partnership-working to mitigate the impact of welfare reform and provide assistance to those most affected has been widely acknowledged. The Welfare Reform update report which was presented to Policy and Resources Committee on 21 April 2014 highlighted the range of initiatives already in place including:
 - the Universal Credit and Council Tax Reduction scheme which offered Welfare Reform Actions Plans and referrals to support services addressing issues such as employment and budgeting
 - innovative implementation of the Scottish Welfare Fund to provide furnishings, carpets and white goods through local social enterprises, support from Dundee Energy Efficiency Advice Project for utility meter top ups, and the use of gift cards for essential groceries
 - early action to advise and support Council tenants who are affected by benefit changes

- the outreach work being undertaken by the CONNECT team funded from a grant of £339,237 from the Big Lottery Support and Connect Fund
- the delivery of digital employability inclusion skills, targeted to individuals who are not IT literate and have restricted internet access resourced from the DWP Flexible Support Fund
- 4.4 The Scottish Government has provided an additional £35m in 2014/15 so that Discretionary Housing Payments (DHP) can be awarded to cover all households impacted by the Under Occupancy Reform. Those applying for a DHP complete a simple one page form and staff have contacted all affected households by phone, text, home visits etc. Figures for the city show that 2,673 households in Dundee are currently impacted by the under-occupancy reform of which 2,582 have a compensatory DHP award in place. This is providing financial support to the value of over £1.8m for the city including Council and Housing Association tenants.
- 4.5 Further evidence of the quality of local welfare reform efforts is demonstrated by the recent announcement that Dundee City Council and Job Centre Plus have been selected to pilot a Local Support Service over the next 12 months. The service will work with voluntary agencies to assist people who need tailored support to make and manage a Universal Credit claim.
- 4.6 A full update of the key poverty related statistics for the city are presented in Appendix A. Significant changes at a national and local level include:
 - Relative poverty, before housing costs (BHC) in Scotland has increased to 16% for the whole population, a 2% point increase on the previous year. In 2012/13 there were 820,000 people living in poverty, 110,000 more than the previous year
 - Relative child poverty (BHC), increased to 19% in 2012/13, up from 15% the previous year. In 2012/13, there were 180,000 children living in relative poverty in Scotland, 30,000 more than in 2011/12. This reverses the trend of declining child poverty over recent years
 - Relative poverty (BHC) among working age adults in 2012/13 was 15%, an increase from 13% the previous year. This brings the number of working age adults in relative poverty to 480,000, an increase of 70,000 compared with 2011/12
 - Relative poverty (BHC) among pensioners in 2012/13 was 15%, an increase from 14% the previous year. There were 150,000 pensioners in relative poverty in 2012/13, 10,000 more than the previous year
 - Six in ten children in poverty in Scotland in 2012/2013 were living in households where at least one adult was in employment
 - 52% of working age adults in poverty in Scotland in 2012/13 were in households where at least one adult was in employment
 - The Minimum Income Standard reported by the Joseph Rowntree Foundation confirms that slow earnings growth and price increases have made households worse off compared to 2008 by between £450 and £4,000
 - the % of working age population in Dundee claiming jobseekers allowance has increased from 4.7% to 5.5% and remains above the Scottish average
 - Dundee remains the local authority with the third highest percentage of its children living in areas within the 15% Most Deprived in Scotland based on all aspects of deprivation. This increased from 35.3% to 36.9% between 2009 and 2012
 - based just on income deprivation, the percentage of children living in the 15% most deprived in Scotland has decreased from 38.6% to 35.5%
 - the number of referrals to Dundee Foodbank increased from 2009 in 2012/13 to 3,679 in 2013/14 and 1,196 referrals were received in first 16 weeks of 2014/15

5. CHILD POVERTY STRATEGY FOR SCOTLAND

- 5.1 On 10 March 2014, the Scottish Government published the Child Poverty Strategy for Scotland : Our Approach 2014-17. This revises and builds upon the original strategy from 2011 which was developed in response to the statutory requirement and the four targets set out in the UK Government's Child Poverty Act 2010.
- 5.2 The Scottish Government reported a decrease in the child poverty rate between 2008/09 and 2011/12 for the three child poverty indicators which have been defined:
 - the percentage of children in relative poverty Before Housing Costs (BHC) decreased from 21% to 15%, a reduction of 60,000 children
 - the proportion of children in absolute poverty (BHC) decreased from 20% to 16%, a reduction of 40,000 children
 - the percentage of children in material deprivation and low income combined decreased from 12% to 8% between 2010/11 and 2011/12, a reduction of 40,000 children
- 5.3 The fourth target on persistent poverty will be available in 2015 derived from the Understanding Society survey carried out by the National Centre for Scotland Research. Despite recent improvements, the Scottish Government anticipated rises in the number of children living in poverty as a result of welfare reform, with the Institute for Fiscal Studies predicting a rise of 50,0000 by 2020. The results of the Poverty in Scotland 2012/13 research which was presented in para 4.2 above confirms that child poverty in Scotland increased by 4% to 19% between 2011/12 and 2012/13; the largest increase for any group.
- 5.4 The main revisions to the strategy are a more explicit emphasis on placed based policy, a better defined outcomes approach and more detailed monitoring and measurement. The revised strategic outcomes for 2014-17 are therefore set out as:

Maximising Household Resources – our aim is to reduce income poverty and material deprivation by maximising financial entitlements and reducing pressure on household budgets among low income families, as well as by maximising the potential for parents to increase family incomes through good quality, sustained employment, and promoting greater financial inclusion and capability (**pockets**).

Improving Children's Wellbeing and Life Changes – our aim is to break inter-generational cycles of poverty, inequality and deprivation. This requires a focus on tackling the underlying social and economic determinants of poverty and improving the circumstances in which children grow up – recognising the particular importance of improving children's outcomes in the early years (**prospects**).

Children from Low Income Households Live in Well-Designed, Sustainable Places – our aim is to address area-based factors which currently exacerbate the effects of individual poverty for many families by continuing to improve the physical, social and economic environments in local areas, particularly in those areas of multiple deprivation in which child poverty is more prevalent (places).

- 5.5 The Scottish Government intends to provide "more robust reporting" across these outcomes and indicators in the 2015 annual report which will also include case studies from Scottish Government, the third sector, local authorities, business and other stakeholders.
- 5.6 The Dundee Fairness Strategy also includes an outcomes framework, in this case, built on the National Framework for Mental Health Improvement developed by Health Scotland which reflects all aspects of community life. While not explicitly addressing the needs of child poverty, all of the Dundee Fairness Outcomes make a significant contribution to the national child poverty outcomes with their emphasis on social and financial inclusion, employment, health and wellbeing and strong socially inclusive communities. The relationship between the two outcome frameworks is demonstrated in Appendix B. To reinforce this connection the progress update in Appendix C has been reframed to reflect the child poverty strategy outcomes.

6 IMPLEMENTING THE DUNDEE FAIRNESS ACTION PLAN

- 6.1 The Fairness Strategy adopted in June 2012 included a detailed action plan with commitments against each of the outcomes which addressed Social Inclusion, Financial Inclusion, Health, Employability and Learning and Communities and Neighbourhoods. Progress is being monitored using the Council's Online Plan Monitoring Database and Appendix C shows full details of the most recent updates provided by lead officers.
- 6.2 Recent significant achievements since the last update in September 2013 include:
 - establishment of ASPIRE Dundee in nine primary schools in the city
 - the concession scheme that has reduced the cost of families taking under 5's to Olympia by $\pounds78,235$
 - creation of a financial capability drama workshop for senior secondary pupils which was performed in all secondary schools in Dundee and filmed to produce a learning DVD
 - introduction of 17 School and Family Development workers delivering one to one support to young people and their families
 - delivery of targeted Family Literacy Learning Sessions to 127 parents/carers in St Mary's and Kirkton
 - raising the funding to Community Regeneration Forums by £76,935 enabling them to support more local projects to promote community spirit and wellbeing
 - securing long-term funding for the roll out of the Equally Well approach to improving community wellbeing
 - development of holiday activity programmes across all wards during April and summer holidays
 - extension of financial inclusion pilot project for ex-offenders to include male offenders
 - completion of Welfare Reform Action Plans for 450 individuals leading to assistance in budgeting, income maximisation and moving towards employment
 - allocation of £960,790 to end March 2014 from the Scottish Welfare Fund
 - supporting 2,939 people to improve their employment prospects through the Dundee Partnership employability pipeline
 - development of the Opportunities Project in the Central Library providing a range of services and facilities to people managing their benefits online and seeking employment
- 6.3 Council departments continue to develop further ways of promoting fairness and reducing deprivation. These will be added to the monitoring database and progress towards these will be included in subsequent reports to Committee:
 - funding from the Robertson Scholarship has been secured to provide 20 annual bursaries to secondary school pupils moving to university
 - support is being given to the expansion of Dundee Foodbank into additional communities
 - joint research into the experience of those affected by welfare reform is being conducted with the Improvement Service
 - the Big Lottery Fund has committed to a targeted funding approach called Our Place in the Douglas community

- 6.4 Despite considerable commitment by the Council and its partners, it is clear that the ongoing economic climate and welfare reform are increasing levels of deprivation in Dundee. To further drive forward the efforts to promote fairness, it is proposed that a Fairness Commission for Dundee is established.
- 6.5 This approach has been adopted in other areas attempting to reverse high levels of poverty and brings together elected members, community members and individuals and organisations who have recognised experience and expertise in this field. Typically, fairness commissions will consider the nature and extent of poverty in the area, consider evidence of what has worked elsewhere to challenge poverty, assess the effectiveness of the Council and partners' existing action plan and make practical recommendations for policy and action to reduce poverty in Dundee.
- 6.6 It is proposed that the Chief Executive prepares a draft list of potential members and remit for the group for Committee approval with further discussion taking place on the final remit and membership once the fairness commission is formed. Secretariat support will be provided by the Chief Executive's Community Planning team.

7 POLICY IMPLICATIONS

7.1 This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management. The Fairness Action Plan and progress in implementing it will make a significant positive impact in tackling poverty in Dundee.

8. CONSULTATIONS

The Director of Corporate Services, the Head of Democratic and Legal Services and community planning partners have been consulted in the preparation of this report.

The SIMD 2009 and SIMD 2012 data within the Fairness Profiles has shown that Dundee City

- remains with the third highest Local Authority share of population living within the 15% Most Deprived in Scotland. This has increased slightly from 28.8% to 29.2%.
- has seen a decrease in the percentage of its population classed as 'income deprived' This has decreased from 20.4% to 17.8% and has seen Dundee City move from being the fourth highest Local Authority to the fifth highest.
- has seen a small increase in the percentage of working age population that are classed as employment deprived from 15.6% to 16.9%. However, Dundee City has dropped from the fourth highest Local Authority to the fifth.

The benefits data within the Fairness Profiles has shown that for Dundee City

- the percentage of working age population claiming jobseekers allowance has increased from 4.7% to 5.5% (quarter 4 2009 and 2012) and remains above the Scottish average figure.
- the percentage of working age population claiming key benefits has decreased from 22.3% to 20.5% (quarter 4 2009 and 2012) but still remains above the Scottish average figure.
- the percentage of working age population claiming Incapacity Benefit or Severe Disablement Allowance has been halved from 7.5% to 3.5% (quarter 4 2009 and 2012) but still remains above the Scottish average figure.

CACI Income Data has shown that for Dundee City:


- the percentage of households within the income category of £0-20k has remained roughly the same with 44.3% and 44.5% in 2009 and 2013 respectively and remains above the Scottish average.
- the Dundee City percentage of households in the £0-20k category is now closer to the Scottish average as the Scottish percentage of households in the £0-20k category has increased between 2009 and 2013. In 2009 the difference was almost 12% now this is just under 10% difference.

The Child Poverty Data sets showed that Dundee City:

- remains the Local Authority with the third highest percentage of its children living in areas within the 15% Most Deprived in Scotland. This has increased from 35.3% to 36.9% between SIMD 2009 and SIMD 2012.
- has seen a decrease in the percentage of its children living in areas within the 15% most income deprived in Scotland this has decreased from 38.6% to 35.5% between SIMD 2009 and SIMD 2012.
- has seen a 0.6% increase in percentage of its children living in poverty (families in receipt of out
 of work benefits or tax credits where their reported income is less than 60 per cent of the median
 income) between 2010 and 2014. This is presently calculated at as 26.4%.
- remains the Local Authority with the second highest percentage of its children living in poverty
- it remains that three quarters of the children living in poverty are from lone parent households
- there has been a small decrease in the percentage of pupils entitled to Free School Meals (FSM) for both primary and secondary. Primary FSM entitlement has decreased from 31% in 2010 to 30.1% in 2013 and secondary has decreased from 22.1% to 20% for the same time period.

The In work Poverty Data set showed that Dundee City:

• has seen a reduction in the number of families in receipt of Working Tax Credits and Child Tax Credits. In 2008/09 this was 5,170 families and in April 2014 this was recorded as 4,700.

Maximise take of school clothing grants, free school meals and Educational Maintenance Allowance	01/07/2014 - Posters regarding Education Maintenance allowances have been distributed to all local authority school establishments, libraries and community centres. Other agencies such as Women's Aid, DWP and playgroups have also received posters. An agreement has been reached with the Housing Department Energy Efficiency Team to supply and confirm receipt of free school meal entitlement to qualify for their white goods scheme. Work is undergoing to enable online electronic application for free school meals. From January 2015 all P1 to P3 children will be provided with school meals
Increase referrals from health services to financial inclusion services	05/05/2014 - NHS Tayside are being kept informed about progress with the City Council's response to the impacts of welfare reforms, so that scope for their involvement can be kept under review. NHS Tayside are awaiting publication of a national report on the National Health Service and its response to the Welfare Reforms. The Welfare Reforms Group will maintain contact and monitor developments. At the Healthy Dundee meeting in February, it was reported that all Health Boards had been advised that they should be preparing an outcomes focussed plan setting out what actions they will take to mitigate the impact of welfare reforms. In Tayside this will be delivered through the NHST Employability and Welfare Reform Forum. As work on that is progressed, the Council will liaise as appropriate to explore setting up a system to facilitate referrals between health services and the financial inclusion advice services in the city
Provide access to financial inclusion advice to individuals as part of their recovery from substance and alcohol misuse	 05/05/2014 - The ADP is continuing to review all services in the city to ensure services are best placed to deliver appropriate interventions to a range of individuals including young people. Current services in the city may require to be redesigned and will ensure that the maximisation of individual's finances remains a top priority in assessment and care planning. The creation of local hubs will ensure easy access to welfare rights advice and support

Improve referrals to advice provision through computerised client referral system	30/05/2014 - The revised CATS system has now been in use for some time. agencies appear to have become comfortable with the new system which is being used extensively. Development of CATS has reached its conclusion for the time being
Increase access to fuel poverty advice through Dundee Energy Efficiency Advice Project	19/05/2014 - It has been agreed with SSE to mail out letters with DEEAP logo targeting DD2/4 postcodes offering a range of services i.e. fuel debt write off, free appliance scheme and Warm Home discount (£140) electricity credit. Initially, the debt in these postcodes exceeds £500,000.
Increase benefit take up and income maximisation	30/05/2014 - In quarter 4 (January to March 2014), 3,263 people sought benefit, money or debt advice. A total of £2,055,666 additional income was generated (including outcomes of benefit appeals). This brought the totals for the year 2013/2014 to 10,994 people provided with advice and support and a total income generated of £7,840,468 additional income generated. (These figures relate to Dundee Partnership or Council funded projects only)
Increase debt advice and representation	30/05 /2014 - Existing debt advice posts have been maintained at present level. Opportunities to fund additional posts is being monitored. Christians Against Poverty service now well established and being used locally
Increase representation for individuals appealing at Benefit Tribunals	05/05/2014 - In quarter 4 (January to March 2014), 355 people were supported at appeal hearings. Of those, 196 had been confirmed as successful with financial gains estimated at £802,473. Around 1,285 appeals were supported in 2013/2014 and a total of £3,567,875 additional income was generated for clients
Provide additional information and support to individuals and households affected by welfare reform changes including all aspects of the introduction of Universal Credit	04/08/2014 - The Welfare Reform Group within the Council continue to raise awareness of the changes. The Council was successful in obtaining funding from the National Lottery which funds a community based outreach team promoting the Welfare Reform Changes including Universal Credit. This team are now operating within community centres, shopping centres within the city. Scottish Government money from the Resilience Fund has been obtained and will allow for an interactive website to be created to highlight the welfare reform changes. In addition, digital IT classrooms will be established throughout the city which will provide further IT access

Target benefit advice to low paid workers	05/05/2014 - Advice agencies are so busy dealing with the impacts of welfare reforms it has not been possible for any of them to allocate resources to a separate campaign to target low paid workers. The Financial Inclusion Strategy Group revisited this at their meeting at the end of March with a view to identifying possible action. Meeting arranged with Support and Connect Team in mid May to discuss reaching low paid workers

Expand use of National Entitlement Card to provide subsidised access to services and facilities	04/07/2014 - All primary school children were issued with KIDZ card (part of the NEC smartcard products) and the process to automatically issue them to P1s is in place. Any member of a household in receipt of Council Tax reduction will receive enhanced concession discounts at L&CD swimming centres by using their NEC card. A review is underway to consider how to extend this facility or promote it better. As part of the launch of the KIDZ card a KIDZ card parentcone facebook page was launched and this has attracted approximately 1,000 liked followers of which 89% fit the profile of local parents. Increase take up of Warm House Discounts	01/05/2014 - The DEEAP submitted 1,118 applications for Warm Home discounts (WHD) crediting household electricity accounts with £135. This is a much needed boost throughout winter. The value of WHD was £150,930.

The uptake, costs and outcomes will be monitored over the next 12 months. Implementation of the agreed plan continues with a steady increase in the number of people accessing Leisure and Culture Dundee facilities under the discount arrangements agreed

Conduct feasibility study into a financial inclusion bill paying service in preparation for impact of Universal Credit	20/05/2014 - Outcome of Government/ABCUL exercise to develop a bill paying service still awaited. Discovery Credit Union still liaising with CredE on its debit card/bill paying facility
Deliver FSA Money for Life programme to students	08/082014 - The Money for Life programme is only promoted intermittently and has been in abeyance for several months while its main sponsors, Lloyds, have been reviewing the contracts for its delivery. Discussions in hand with a local film-maker about filming a performance for use as a Scotland wide teaching resource. Dates set for performances in Dundee schools in June 2014.
