1 PURPOSE OF REPORT

1.1 This report reviews the performance of City Development Department in relation to its Service Plan 2012-2017

3 FINANCIAL IMPLICATIONS

3.1 All actions are within the Department's approved budget.

4 BACKGROUND

- 4.1 The Department has made the following improvements or sustained a target level in its priority performance indicators -
 - Number of businesses assisted to trade out-with Scotland has been maintained at above target level
 - Number of business tourism events secured by Dundee and Angus Convention Bureau at above target levels
 - Increase in the number of production days secured by Tayscreen
 - Increase in the number of new social enterprises
 - Increase in effective housing land supply
 - Increase in the percentage of planning applications approved in accordance with Local Plan policy on low and zero carbon technology in new developments
 - Increase in the proportion of payment of parking fees/penalties by self service
 - Increase in the percentage of major capital project costs monitored against national BCIS indices
 - Increase in the percentage of recycled materials used within major capital plan construction programmes (% of works value)
 - Decrease in energy consumption per street light (watts)
 - Increase in the percentage of street lights that are dimmable
 - Increase in the percentage of traffic signals repaired within 48 hours
 - Decrease in the average number of weeks to make decisions on major planning applications
 - Increase in the percentage of building warrant applications responded to within 20 working days

- 4.2 The following indicators have shown a decline in trend and will be the subject to detailed performance review in the period ahead -
 - Percentage of children walking or cycling to school
 - Percentage of respondents who are fairly or very satisfied with public transport in Dundee (including no opinions)
 - Street Lighting Percentage of repairs completed within 7 days
 - Percentage of unemployed people assisted into work from Council operated / funded Employability Programmes has declined.

4.4 Highlights

The Department's key achievements during the year were:

- Central Waterfront Project major infrastructure work progressed on schedule and is due for completion in Spring 2016. Marketing activity generated strong developer interest in a number of plots
- Construction of the new Seabraes Bridge was completed and opened in June 2015.
- Site clearance for the new Railway station complex was completed and a tender process for construction of the new facility undertaken.

- V&A Dundee further funding was secured from the Heritage Lottery Fund and Scottish Government towards the construction costs of V&A Dundee. A construction contract was signed and work commenced in March 2015
- Completion and opening in September 2014 of The Crescent
- Vacant and Derelict Land Remediation development of new housing proposals on vacant sites in Lochee, Whitfield and Mill of Mains commenced
- Developing Low Carbon Transport Modes City Development Committee approved a Sustainable Urban Logistics Plan in October 2014, Stagecoach announced plans to introduce 18 new diesel electric hybrid vehicles and the Co-Wheels Car Club introduced electric vehicles to their fleet
- Delivery of Capital Programme- a Capital Governance Group was established to monitor and drive delivery of major projects

4.5 Areas for improvement

On reviewing the service plan the department aims to ensure improvement next year on the following:

- Employability ongoing welfare reform changes and proposals to devolve delivery of the
 Department of Work and Pensions Work Programme and Work Choice to Scotland have
 altered the landscape. Consequently, a major review focusing on how to improve
 employability outcomes is underway and will inform improvement activity over the next
 year
- 4.6 The Department carries out self-assessment using the Public Sector Improvement Framework (and/or where relevant was subject to external assessment). This identifies strengths and areas for improvement. A self assessment of the Economic Development Service area was carried out in 2014/2015 and a report detailing improvement actions was approved by Scrutiny Committee in February 2015. The priority areas for improvement will be taken forward in the next Department Plan.

4.7 New Actions

Based on the Single Outcome Agreement, Council Plan and Department Plan reviews and new issues arising throughout the year the department proposes adding the following new strategic actions to its service plan for and will feature in future performance reports:

 Develop an updated citywide employability strategy supported by the Dundee Partnership based on findings from the review of employability in Dundee

4.8 New Performance Indicators
