- Replacement Cess Collector, James Lyons to pay 500 merks to complete the cess collection (5th December, 1685).

- Baillies Balnoavis and Arbothnot to audit John Haistier, Cess Collectors accounts (19th January, 1686).

- John Haistier, Cess Collector, to pay £300 to the founder, in part payment for the work on the bell (5th May, 1686).

Duncan, John (Former Baillie)

• To assist Baillie Mundie in auditing William Ffairweather (late Shoremasters) accounts (19th January, 1686).

<u>Fines</u>

- Magistrates absent on Council days fines five shillings and twelve shillings for absence from church (29th September, 1685).
- James Stewart appointed collector of the fines (29th September, 1685).
- James Stewart to return £10 to Robert Gardyne the Goldsmith (9th March, 1686).

Grammar School

- George Menzies to be doctor of the grammar school in place of the deceased Mr. Alexander Ramsay (20th July, 1686).

Hospitalmaster (James Alisone)
