Code of Conduct

The Leisure & Sport Section of Leisure & Culture Dundee operates a Code of Conduct. A summarised Code of Conduct for all participants and parents/guardians is signed by the parent/guardian through the corporate booking process as follows:

“The Leisure & Culture section of Leisure & Culture Dundee asks participants and their parents/carers to adhere to its Codes of Conduct to ensure the health, safety and enjoyment of all participants. Failure to do so could result in the participant being excluded from the class/activity. The following are examples of some of the Codes of Conduct that should be adhered to:

- Be safe at all times.
- Follow the instructions and listen to the activity leader at all times.
- Respect each other - no hitting/pushing/put downs or swearing.
- Take care of all property and equipment being used.
- Be considerate to others and work as a team.
- Do not leave sessions without the permission of those in charge.
- Contribute to creating a positive environment to help and support everyone's learning and development of life skills.

The full version of the Leisure & Sport Code of Conduct is as follows:

No person shall:

- access the relevant activities without having first paid for the activity or obtained permission by the lead officer or lead coach on site;
- enter the premises or attend activities while knowingly suffering from any contagious or infectious disease;
- bring or cause to be brought into the relevant premises any unauthorised alcoholic or intoxicating liquor or drugs;
- attend the relevant activity while in possession of or under the influence of alcohol or drugs;
- smoke in or around the relevant premises/activity;
- record video footage or take photographs in or around the activity being participated in;
- use profane, indecent or offensive language or behave or conduct oneself in an indecent, offensive, insulting, disorderly or violent manner;
- wilfully damage any article belonging to Leisure & Sport, partner organisations or participants, or attempt, plan or conspire or do any act likely to wilfully damage the same;
- bring to the activity any item that can cause physical harm to participants or staff including knives, weapons or glassware of any description;
- fail to comply with all instructions provided by Coaching and facility staff to ensure safe conduct within and around the activities provided.

Protection of Privacy: All participants and parents shall observe all facility management rules where activities take place including supervision of changing, toilet use etc.

Valuables and Clothing: Leisure & Sport shall not be held responsible and does not accept liability for the loss of (or damage to) wearing apparel, property or valuables left in the dressing rooms or any other part of the relevant premises at which activities are organised. Persons using relevant premises must use any lockers provided for storage of clothing and valuables.

Dress and Equipment: Leisure & Sport reserves the right to refuse any participant entry to activities if his or her dress is considered by the Lead officer, Coach or Facility Manager to be unsuitable or unsafe for the activity.

Exclusion of Animals: No person shall allow any dog (*other than a working dog accompanying a disabled person*) or other animal under his or her control, or belonging to him or her, to enter any premises where activities except with the express consent of the Manager. ", shall be exempt from this rule.

Expulsions or Exclusion for Breach of Rules: The Leisure & Sport Manager may, if he/she has reasonable grounds for believing that a person has contravened, is contravening or is about to contravene any of the foregoing rules, expel or exclude that person from the relevant activity. A person who persistently or seriously contravenes or attempts to contravene the foregoing rules and is, in the opinion of Leisure & Culture Dundee likely to contravene them again, shall be liable to be made the subject of an exclusion order the length of which will be determined by the Leisure & Sport Manager and the Officer responsible for the Programme.
