A consultation was carried out between 12th January, 2021 and 29th January, 2021 for new street names at the above location.

The consultation correspondence was sent to Ward Councillors, Convener, City Archivist, Council Officers and the agent, KDM Architects.

No suggestions or comments were received and a search of historic data for the area did not raise any suitable names therefore Council Officers propose the name of 'Longfield' which is a combination of parts of Longhaugh and Whitfield.

Committee is therefore asked to approve the following new street names:

Longfield Place Longfield Crescent Longfield Drive.

(c) HOUSING DEVELOPMENT – LAND NORTH OF OLD QUARRY ROAD

A consultation was carried out between 16th February, 2021 and 5th March, 2021 for a new street name at the above location.

The consultation correspondence was sent to Ward Councillors, Convener, City Archivist, Council Officers, the Whitfield Development Group and the agent, Jon Frullani Architects.

The agent suggested the street name 'Golf View'

No other suggestions or comments were received therefore it is proposed to put forward the agent's suggestion for approval.

Committee is therefore asked to approve the following new street name:

Golf View.

(d) HOUSING DEVELOPMENT – LAND TO THE SOUTH OF COLDSIDE ROAD AND WEST OF STRATHMARTINE ROAD

A consultation was carried out between 3rd March, 2021 and 26th March, 2021 for a new street name at the above location.

The consultation correspondence was sent to Ward Councillors, Convener, City Archivist, Coldside Community Forum, Council Officers and the agent, KDM Architects.

No suggestions were received therefore Council Officers propose to use the existing Coldside name keeping a historic link with the area.

Committee is therefore asked to approve the following new street name:

Coldside Place.

(e) HOUSING DEVELOPMENT – FORMER TAYBANK WORKS, MORGAN STREET

A consultation was carried out between 8th March, 2021 and 26th March, 2021 for a new street name at the above location.

The consultation correspondence was sent to Ward Councillors, Convener, City Archivist, Stobswell Forum, Council Officers and the agent, KDM Architects.

Suggestions were received from a local Councillor, residents and the Stobswell Forum. All suggestions pertained to local history/area.

The Stobswell Forum suggested naming the street after Billy Mackenzie, a former Stobswell resident and a worldwide music icon.

After discussions with Council Officers, it is proposed to put forward the name to commemorate Billy Mackenzie.

The Mackenzie family has been consulted on this and feel this is an honour to the memory of Billy.

Committee is therefore asked to approve the following new street name:

Billy Mackenzie Street.
