1 PURPOSE OF REPORT

- 1.1 The report sets out the revised Development Plan Scheme for the Dundee Local Development Plan.

2 RECOMMENDATION

- 2.1 It is recommended that the Committee
- a Approve the revised Development Plan Scheme as set out in Appendix 1.
 - b Refer the revised Development Plan Scheme to the Scottish Government for information.
 - c Remit the Director of City Development to publish and implement the Development Plan Scheme.

3 FINANCIAL IMPLICATIONS

- 3.1 The financial implications from this report are contained within the City Development Department budget.

4 BACKGROUND

- 4.1 The Planning etc (Scotland) Act 2006 requires each Planning Authority to prepare a Development Plan Scheme, and review it annually.
- 4.2 The Development Plan Scheme sets out the Authority's programme for preparing and reviewing their Local Development Plan and gives a general indication of what is involved in each stage, together with dates for key stages in the process.
- 4.3 The Development Plan Scheme also includes a "participation statement" stating the expected timescales for consultation on the plan preparation
- 4.4 After adopting the Development Plan Scheme, the Act requires the authority to publish it, send two copies to Scottish Ministers and place copies in public libraries. There is no requirement to consult on the content of Development Plan Scheme nor receive ministerial approval.
- 4.5 Preparatory work has commenced on preparing the Dundee Local Development Plan. The timescales for this were set out in the first Development Plan Scheme which was approved by Committee and published in March 2009.

5 REVISED DEVELOPMENT PLAN SCHEME

- 5.1 Dundee City is one of four designated City Region areas under the 2006 Planning etc (Scotland) Act. As such there are two Development Plan Schemes which affect the City. This report relates only to the Development Plan Scheme associated with the Local Development Plan. The Development Plan Scheme associated with the Strategic Development Plan is prepared by TAYplan in association with the partner authorities of Dundee, Perth & Kinross, Angus and Fife.
- 5.2 The preparation of the Local Development Plan is linked by legislation to the timescales for the production of the TAYplan Strategic Development Plan. As a result the preparation of the Local Development Plan cannot progress ahead of the main stages of the Strategic Development Plan preparation process.
- 5.3 There are two main stages in the preparation of the Strategic Development Plan which affect the timescale for the preparation of the Local Development Plan. The first of these relates to the publication of the Proposed Strategic Development Plan. The advice set out in Circular 1/2009 advises that the Main Issues Report for the Local Development Plan should not be published prior to the publication of the Proposed Strategic Development Plan. The second requirement relates to the timescale for submission of the proposed Local Development Plan to Scottish Ministers. It is advised that this should not be done until the Strategic Development Plan has been approved by Scottish Ministers.
- 5.4 TAYplan are currently updating the timescale for the preparation of the Strategic Development Plan and revising their Development Plan Scheme. The Development Plan Scheme for the Local Development Plan, as contained in the appendix to this report, has been revised to take these changes into account. As a result the key dates for the preparation of the Local Development Plan are as follows:
- a Publication of Main Issues Report - August 2011
 - b Publication of the proposed Local Development Plan - August 2012
 - c Examinations of proposed Local Development Plan Summer 2013
 - d Adoption of Local Development Plan - Summer 2014
- 5.5 Following the publication of the previous Development Plan Scheme in March 2009, The City Development Department has been undertaking preparatory work in support of the Local Development Plan preparation process. This has included an assessment and review of the strategy and policies of the Dundee Local Plan Review 2005, an initial meeting with all of the Key Agencies and a series of departmental workshops identifying issues for consideration in the Main Issues Report. Progress has also been made on preparing a consultation/communication strategy for engaging with interested parties including an initial awareness raising exercise.

6 CONCLUSIONS

- 6.1 The Scottish Government has placed a duty on planning authorities to prepare a Development Plan Scheme on an annual basis. Dundee's first Development Plan Scheme was published in March 2009.

- 6.2 The Development Plan Scheme prepares the way for the introduction of a Local Development Plan and sets out the expected timescales for plan production and consultation over the next twelve months.
- 6.3 The Proposed Development Plan Scheme for 2010 has been prepared taking into account the revised timescale for the preparation of the TAYplan Strategic Development Plan and is contained within Appendix 1 of this report.

7 POLICY IMPLICATIONS

- 7.1 This Report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.

There are no major issues.

8 CONSULTATIONS

- 8.1 The Chief Executive, Depute Chief Executive (Support Services), Director of Finance and Assistant Chief Executive have been consulted and are in agreement with the contents of this report.

APPENDIX 1

DUNDEE CITY LOCAL DEVELOPMENT PLAN SCHEME 2010

This is the second Development Plan Scheme published by Dundee City Council with regards to the preparation of the Dundee Local Development Plan. It contains updated information on the progress made towards preparing the Local Development Plan and amended timescales for the main stages of the plan preparation process.

Background

The Planning etc (Scotland) Act 2006 has introduced a process for the replacement of Structure Plans with Strategic Development Plans covering the four main city regions of Scotland and the replacement of Local Plans with Local Development Plans.

The Strategic Development Plan for the area is being undertaken by TAYplan Strategic Development Planning Authority (SDPA), whilst Dundee City Council is undertaking the preparation of the Local Development Plan.

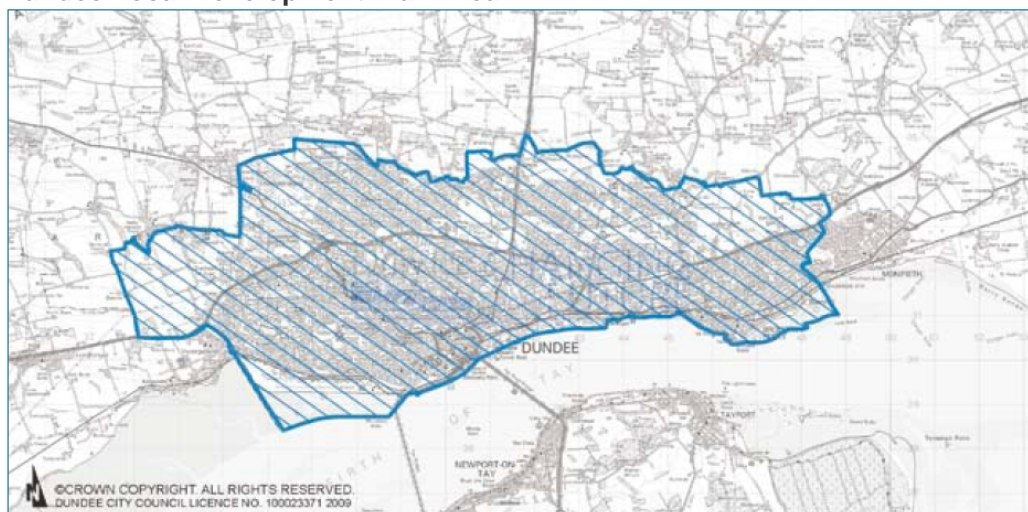
This Development Plan Scheme refers only to the Dundee Local Development Plan.

Once both plans are completed, the Strategic Development Plan and the Local Development Plan will form the statutory Development Plan for the Dundee City Council Area. In addition, Supplementary Planning Guidance on a specific planning topic may be prepared and form part of the Development Plan.

The existing Local Plan is the Dundee Local Plan Review 2005. This plan remains in force until such time as its replacement Local Development Plan is adopted.

The area to be covered by the Local Development Plan is the entire Dundee City Council administrative area.

Strategic Environmental Assessment

The Environmental Assessment (Scotland) Act 2005 makes SEA a legal requirement for certain plans, programmes and strategies, including the Local Development Plan.

The purpose of SEA is to provide proper consideration for the environment by ensuring that environmental issues are considered by decision makers alongside economic and social issues. This is achieved by systematically assessing the potential significant environmental effects of the plan. The process involves a number of key stakeholders including the Scottish Environment Protection Agency, Scottish Natural Heritage, and Historic Scotland.

The SEA will be undertaken in conjunction with the Local Development Plan and where possible consultation events for both will be run concurrently. The SEA findings will be published in an environmental report.

Preparing the Local Development Plan

The main stages of the process to prepare and implement the Local Development Plan are:

- 1 Publication of a Development Plan Scheme, including Participation Statement (this document)
- 2 Preparation and Publication of a Monitoring Statement
- 3 Preparation and Publication of a Main Issues Report
- 4 Preparation and Publication of a Proposed Plan, and Proposed Action Plan
- 5 Submission of the Proposed Plan, Action Programme and statement of conformity with the participation statement to Scottish Ministers
- 6 Examination (to consider any outstanding representations)
- 7 Adoption Of Plan

Following publication of the first Development Plan Scheme in 2009, Dundee City Council has undertaken a number of tasks in support of the plan preparation process. This has included a monitoring exercise based on the Dundee Local Plan Review 2005 which is due for publication alongside the Main Issues Report. Initial consultation with the Key Agencies has taken place and assisted in the formulation of procedures for further communication and consultation.

To assist with the formulation of the Main Issues Report and raise general awareness of the plan preparation process an initial consultation exercise is to be undertaken during the summer of 2010. This consultation is expected to target a wide range of groups and individuals and in doing so, should also serve to increase the numbers who register to be involved in future consultation exercises.

Local Development Plan - Timetable

As part of the Development Plan Scheme Ministers require that Councils set out a broad timetable for the stages in the preparation of their plan.

The timescale for preparation of the Local Development Plan is linked with that of the TAYplan Strategic Development Plan. The Local Development Plan cannot progress in advance of the Strategic Development Plan. Therefore, any changes to the timings for the preparation of the Strategic Development Plan may influence those of the Local Development Plan.

The revised Development Plan Scheme for the TAYplan Strategic Development Plan includes amendments to the timings for the main stages of the plan preparation process. These changes affect the timescales for the preparation of the Local Development Plan and have been taken into account in the revised timetable.

The timetable below sets out the revised timings for the main stages of the Local Development Plan process.

Participation Statement

Dundee City Council is strongly committed to encouraging participation with wide stakeholder and public involvement in the preparation of the Local Development Plan.

By inviting involvement at all stages of the Plan's preparation, the Council seeks to ensure that those with an interest in the area e.g. members of the public, businesses, key organisations and community groups, have an opportunity to contribute their views before decisions are taken. This applies equally to those who support elements of the plan as to those who wish to make objections.

In doing so the Council will seek to ensure that:

- Arrangements for participation are as open, transparent and practical as possible
- Information is provided fully and as early as possible
- Communication is provided through appropriate and widely accessible means, in particular by use of the council's website

The participation exercise will seek to involve a wide range of parties including:

- Public Sector Groups (including key government departments and agencies)
- Private sector groups (including business, retail and housing interests)
- Established Community Groups (including Community Councils)
- Voluntary and environmental organisations
- Local Community Planning Partnerships (LCPP)
- General members of the community, including younger citizens

The Local Community Planning Partnerships (LCPP) are a key mechanism within Dundee for communication within the community. These partnership groups offer full coverage of the plan area and are supported by communities officers. In addition to attendance by officers from throughout Dundee City Council, the LCPP is also attended by representatives of the emergency services, health and voluntary sectors thus allowing a broader consideration and greater interpretation of issues raised.

The Council is keen to encourage interested individuals, groups and organisations or any other party, to participate in the preparation of the Dundee Local Development Plan. To assist the Council in ensuring that those who want to be involved in the process are kept up-to-date on progress there is the opportunity to register contact details to receive future correspondence.
