REPORT ON: UK SHARED PROSPERITY FUND MULTIPLY ADULT NUMERACY INTERVENTION

1. PURPOSE OF REPORT

- 1.1 To inform committee of the proposed delivery approach for the UK Shared Prosperity Fund (UKSPF) Multiply adult numeracy programme interventions.
- 1.2 The report seeks approval for a waiver of tender procedures to award a contract to Dundee and Angus College as Dundee and Angus College is understood to be the only further education provider in the area with the ability to deliver key aspects of the proposed Multiply interventions to scale and to the required academic level. A "VEAT" Notice (voluntary ex ante transparency notice) in terms of Regulation 91 of the Public Contracts (Scotland) Regulations 2015 shall be made prior to the intended award to alert the market place of this intended award (allowing any other potential provider to make itself known although this is not considered at all likely).

2. **RECOMMENDATIONS**

It is recommended that Neighbourhood Services Committee:

- a. approves the request for waiver of tender procedures to enable Dundee and Angus College to deliver specific Multiply interventions to 800 adults after completion of a "VEAT" Notice.
- b. delegate authority to the Executive Director Neighbourhood Services to progress the development of the partnership with Dundee and Angus College to deliver specific Multiply interventions.
- c. remits Neighbourhood Services to contribute to an annual report submitted by the Executive Directors of Corporate Services and City Development on progress of the delivery of the UKSPF Investment Plan (including Multiply) to City Development Committee.

3. FINANCIAL IMPLICATIONS

- 3.1 There are no direct financial implications for Dundee City Council as the following will be funded from the conditional allocation of funding from UKSPF to Dundee allocated from 1st April 2022 to 31st March 2025. The overall aim of the UKSPF is to address key challenges locally by focusing interventions across three key themes:
 - People and skills;
 - Local business support; and
 - Communities and place
- 3.2 As part of Dundee's UKSPG allocation, £968,616 is ring-fenced for the Multiply adult numeracy programme to be managed by Neighbourhood Services. The intended allocation to Dundee and Angus College is up to £400,000 from 1st April 2023 to 31st March 2025, to support the delivery of specific Multiply interventions.

4. MAIN TEXT

- 4.1 The Multiply programme is a ring-fenced funding stream of the UK Shared Prosperity Fund with a focus on supporting adults aged 19 plus to improve their functional numeracy skills, through the delivery of pre-specified interventions. The Multiply element of the fund is being led by Neighbourhood Services.
- 4.2 The aim of Multiply is to increase the levels of functional literacy in the adult population and includes the following success measures.
 - More adults achieving a maths qualifications/participating in numeracy courses leading to :
 - Improved labour market outcomes
 - Increased adult numeracy across the population
- 4.3 To ensure the programme reaches the target numbers and a wide range of learners Multiply will be delivered through a mixed delivery model, including:
 - £392,000 over 2023/24 and 2024/25 for direct delivery from Dundee City Council, through the recruitment of 3 Community Learning and Development Workers, managed by a Senior Community Learning & Development Worker who will work with learners to help them improve their confidence in everyday numeracy, including parents and those who want a first step towards a numeracy qualification and those in employability programmes
 - a challenge fund of up to £176,616 over 2023/24 and 2024/25 open to the Third Sector to enable local partners to enhance or extend existing provision to reach and engage more adults in numeracy learning activities
 - Dundee and Angus College contribution of up to £400,000 over 2023/24 and 2024/25 as specified in 4.4
- 4.4 Dundee and Angus College will be contracted to deliver the following specific interventions:

S46: Additional relevant maths modules embedded into other vocational courses

S47: Innovative programmes delivered together with employers – including courses designed to cover specific numeracy skills required in the workplace

S48: New intensive and flexible courses targeted at people without Level 5 maths in Scotland, leading to an equivalent qualification

4.5 Interventions **S46**, **S47** and **S48** relate to very specific learning offers which it is understood can only be delivered at scale by Dundee and Angus College as the only local Further Education provider of vocational courses, workplace academies and courses leading to an SQA Level 5 qualification, or equivalent. Approximately 800 learners will experience improved life chances through participation in Multiply at Dundee and Angus College.

As the only further education provider in Dundee, Dundee and Angus College supports approximately 23,000 adults across a range of subjects and levels. The College has extensive experience in developing and delivering SQA qualifications. The College is best placed to deliver elements of the Multiply programme and thereby reach an additional 800 learners.

4.6 This request for a waiver of tender procedures following a "VEAT" Notice would enable Dundee City Council to develop a meaningful partnership with Dundee and Angus College to develop and deliver a broader range of Multiply interventions and therefore improve the lives of a wider range of adult learners.

5. POLICY IMPLICATIONS
