1. PURPOSE OF REPORT

To seek approval for the purchasing of play equipment for Camperdown Play Complex and digital surveying as part of phase 2 playground report.

2. RECOMMENDATION

2.1 It is recommended that due to the specialist nature of the equipment and in terms of regulations governing the tender procedures of the Council, the offers from specialist supplier Kompan Ltd, Milton Keynes of £24,415 for the supply of specialist play equipment and from Douglas Land Surveys, Fife of £550 for the digital survey are accepted.

3. FINANCIAL IMPLICATIONS

The total cost of £24,965 can be met from the provision in 2001/02 Leisure & Parks Department Capital Budget.

4. LOCAL AGENDA 21 IMPLICATIONS

- 4.1 The equipment that has been removed will be refurbished or re-used, where possible to improve other areas. The equipment and materials that are not being re-used will be recycled. This will ensure that removal of the play area does not create a problem of excessive disposal of materials and the environmental implications that would result.

- 6.1 Works to complete phase 2 of the Play Area Report includes the purchase of equipment for the refurbishment of Camperdown Play Complex and digital survey work.
- 6.2 Due to the specialist nature of the equipment that in terms of regulations governing the tender procedures of the Council, Kompan Ltd is proposed as specialist supplier for the supply of Play equipment for the refurbishment of Camperdown Play Complex. The play equipment specified below is of a specialist design based on boats and nautical play equipment to continue the theme of the Battle of Camperdown Play Complex.
