1.0 PURPOSE OF REPORT

The report considers the outcome of consultation relating to the proposed extension to the Animal Exclusion Zone at Broughty Ferry beach and seeks to obtain approval for additional signage for the beach and adjacent parks.

2.0 RECOMMENDATIONS

It is recommended that members;

- 2.1 agree that the Animal Exclusion Zone is not extended to the entire beach but it is confined to the existing zone.
- 2.2 agree that the Exclusion Zone is operative on a seasonal basis from the 1st May to 30th September annually.
- 2.3 remit to Leisure and Arts, Park Rangers and Environmental and Consumer Protection Department Animal Control Officers to continue to monitor and enforce management rules.
- 2.4 accept the offer received from T R L Signs, Hamilton for additional beach signage at £2762.28
- 2.5 agree to the beach being considered an area where owners may not permit a dog to foul, in terms of Section 48 (2) of the Civic Government (Scotland) Act 1982.

3. FINANCIAL IMPLICATIONS

3.1 The cost of the signage is £2762.28 which can be met from the Leisure and Parks Department's 2001/02 Capital Budget.

4. LOCAL AGENDA 21 IMPLICATIONS

4.1 The proposals support the principle of Local Agenda 21 priority by promoting the key theme where health is protected by creating safe, clean and pleasant areas.

5. EQUAL OPPORTUNITIES

The implementation of the Exclusion Zone will enhance individual opportunities for safe and healthy leisure pursuits.

6. BACKGROUND

6.1 Reference is made to Article II of the minute of meeting of the Leisure Services Committee of the 17th April, 2000 when approval was given to develop and implement an Animal Exclusion Zone on Broughty Ferry Beach all as part of the overall strategy and long term objective of achieving Blue Flag Status for the beach.

Officers were instructed to brief the public on the implementation of the Animal Exclusion Zone and seek consultation on the possibility of including other areas from the entire beach and report to Committee on the above.

- 6.2 Public consultation was carried out through distribution of questionnaires to organisations, through a display at Broughty Ferry Library and through attendance at events, in particular the Broughty Ferry Gala day where a display was set up and staff were on hand to offer advice and information.
- 6.3 A majority of respondents were in favour of the Animal Exclusion Zone not being extended, and for the ban to be seasonal.
- 6.4 In conclusion it is recommended that the Animal Exclusion Zone is not extended at this stage and that it operates on a seasonal basis which is in line with criteria related to the Blue Flag areas.
- 6.5 In addition to the operation of the Animal Exclusion Zone, the entire beach can be considered an area where owners may not permit a dog to foul, in terms of Section 48(2) of the Civic Government (Scotland) Act 1982.
- 6.6 Supplementary signage is required under Section 48(2) of the Civic Government (Scotland) Act 1982 to specify the area as an area maintained by the Local Authority and used for recreational purposes. Once designated with the signage, the beach will be an area where dog fouling is an offence. This should ensure that dog owners are aware of their responsibilities and subject to appropriate enforcement.
