### 1.0 PURPOSE OF REPORT

1.1 To seek approval for the hire of marquees as required by the Director of Environment for the Dundee Flower and Food Festival.

## 2.0 RECOMMENDATIONS

2.1 It is recommended that the committee approve the hire of marquees for 2014 at a total cost of £60,172.25 as outlined below, and the Director of Environment be authorised to agree any future extensions for the following two years.

### 3.0 FINANCIAL IMPLICATIONS

3.1 The Director of Corporate Services advises that the overall cost of hiring the marquees can be met from the Dundee Flower and Food Festival's account.

## 4.0 MAIN TEXT

4.1 An invitation for the hire, transport, erection and taking down, anodised aluminium or steel clear span frame tents for the 2014 Dundee Flower and Food Festival was prepared and posted on the Public Contracts Scotland Portal. Tenders were invited for one year with the option by the Council for a further extension for two years. Tenders were received and evaluated as follows:-
