1 PURPOSE OF REPORT

- 1.1 This report summarises the representations received to the proposed non-statutory planning guidance on the Dundee Green Network from the period of public consultation. It also seeks approval of the proposed modifications to the planning guidance in response to the representations.
- 1.2 The summary of issues raised and proposed modifications is attached as Appendix 1.

2 RECOMMENDATION

- 2.1 It is recommended that the Committee:
- a notes the summary of the issues raised in the representations received to the proposed non-statutory planning guidance, the response to these by the Council and approves the proposed modifications as set out in Appendix 1;
 - b agrees to the adoption of the non-statutory planning guidance; and
 - c agrees that the City Development Department will work in partnership with Neighbourhood Services to ensure that the non-statutory planning guidance is kept up to date.

3 FINANCIAL IMPLICATIONS

- 3.1 There are no financial implications arising as a result of this report.

4 BACKGROUND

- 4.1 In line with national and strategic planning policy, the Council's City Development Department and Environment Department (now Neighbourhood Services) have been working jointly together on a project with Scottish Natural Heritage to identify the existing key networks of green infrastructure in the city and opportunities to enhance them. The outcome of this is promoted in draft non-statutory planning guidance on the Dundee Green Network. Reference is made to Article IV of the Minute of the Meeting of the City Development Committee of 28 September 2015 Report 314-2015 where it was agreed to issue the draft non-statutory planning guidance for a 6 week period of public consultation.
- 4.2 Interested parties including statutory bodies, private and public parties, community groups and the general public were invited to comment on the draft non-statutory planning guidance from 1 October 2015 – 13 November 2015. Twenty four representations were received in total from a number of individuals and organisations including Dundee Civic Trust, Transform Scotland, RSPB and Friends of the Earth Tayside. Key agencies including Scottish Environment Protection Agency, Scottish Natural Heritage, Historic Environment Scotland and the Scottish Government also responded.
- 4.3 In the main, respondents welcome and support the non-statutory planning guidance. Scottish Natural Heritage has been involved in the development of the planning guidance and support

the work that has been carried out. Scottish Government welcome that the planning guidance is the product of collaborative work with Scottish Natural Heritage and that the planning guidance is predominantly map based and visual. All issues raised during the consultation period are summarised in Appendix 1. A number of improvements to the non-statutory planning guidance have been recommended and where suggested changes have not been accepted an explanation for this has been provided in Appendix 1.

- 4.4 The non-statutory planning guidance is a visual map based tool which will be available on the Council's website for use by developers, key agencies and the general public. It is intended that City Development Department and Neighbourhood Services will work in partnership to maintain the information contained in the non-statutory planning guidance to ensure it is accurate and up to date.

5 POLICY IMPLICATIONS

- 5.1 This Report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management. The major issues identified:

- a the Strategic Environmental Assessment (SEA) is a legal requirement under the Environmental Assessment (Scotland) Act 2005 that applies to all qualifying plans, programmes and strategies, including policies;
- b the matters presented in this report were considered under the Environmental Assessment (Scotland) Act 2005 and the required pre-determination screening has been undertaken under Section 9 of the Act. The screening identified that the draft non-statutory planning guidance will have no significant environmental effects and the SEA Gateway is in agreement;
- c Article 6(3) of the EC Habitats Directive requires that any plan (or project), which is not directly connected with or necessary to the management of a European site, but would be likely to have a significant effect on such a site, either individually or in combination with other plans or projects, shall be subject to an "appropriate assessment" of its implications for the European site in view of the site's conservation objectives. This procedure is applied in Scotland through The Conservation (Natural Habitats, &c) Regulations 1994 (as amended), and is known as the "Habitats Regulations Appraisal" of plans; and
- d the screening stage of the Habitats Regulations Appraisal identified that the draft non-statutory planning guidance on the Dundee Green Network is not likely to have a significant effect on a European site. Scottish Natural Heritage (SNH) is in agreement with this and SNH confirm that no further consideration is required.

6 CONSULTATIONS

- 6.1 The Chief Executive, the Executive Director of Corporate Services, Head of Democratic and Legal Services and Executive Director of Neighbourhood Services have been consulted and are in agreement with the contents of this report.

7 BACKGROUND PAPERS

- 7.1 There are no background papers of relevance to this report.
