#### 1.0 PURPOSE OF REPORT

1.1 To authorise the purchase of shredder parts for use in the recycling equipment at Baldovie Waste Processing Plant within Waste Management.

#### 2.0 **RECOMMENDATIONS**

2.1 It is recommended that the offer detailed from the specialist supplier below is accepted.

Supply of replacement cutters, spacers, pinions and bull gear:

Ulster Engineering Ltd £38,000

#### 3.0 FINANCIAL IMPLICATIONS

3.1 The total cost of the spare parts is £38,000. Provision for this expenditure has been made in the Waste Management Department's Capital Budget for 2008/9.

#### 4.0 MAIN TEXT

- 4.1 These spare parts form part of an overhaul of the waste shredding systems at Baldovie. The shredding process allows a substantial amount of commercial and civic amenity waste to be either recycled or rendered as fuel at the DERL Energy from Waste plant.
- 4.2 It is not possible to tender for this equipment since it can only be sourced from the equipment manufacturer. The prices quoted however do include a rebate on the old parts which are to be returned and recycled.

#### 5.0 POLICY IMPLICATIONS

5.1 This Report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.
