### 1.0 PURPOSE OF REPORT

1.1 To inform the Committee of the outcome of the first year of the award scheme.

### 2.0 RECOMMENDATION

2.1 That the Committee note the contents of the report.

## 3.0 FINANCIAL IMPLICATIONS

- 3.1 Expenditure on the scheme was £6,000. £3,000 was met from a grant from the Scottish Arts Council and £3,000 from the Arts and Heritage Department's 2000/01 revenue budget.
- 3.2 This is the first of three years commitment to the Dundee Visual Arts Awards Scheme.

### 4.0 LOCAL AGENDA 21 IMPLICATIONS

- 4.1 The project was established to reflect the key theme "opportunities for culture, leisure and recreation are readily available for all"
- 4.2 The criteria gear the project to locally based artist required to live or have regular commitment to the City by working or regularly using facilities such as artist studios.

## 5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The project is open to all artists within the community regardless of ability, social background, race, sex or disadvantage.

### 6.0 MAIN TEXT

- 6.1 The Dundee Visual Arts Awards scheme is a partnership between Dundee Arts and Heritage Department and the Scottish Arts Council. It is a new initiative increasing the level of support for visual artists in the area and there are similar schemes in Edinburgh, Aberdeen, Glasgow and the Highlands & Islands.
- The panel has included practicing artists Mary Bourne, Sculptor; Paul Dignan, Lecturer at Duncan of Jordanstone; and Chris Byrne, Director of New Media Scotland with support from the Scottish Arts Council Officers and Arts and Heritage Officers.
- 6.3 The number of artists applying for the awards totalled 29, 14 in October 2000 and 15 in February 2001. The number of awards made on each occasion was 7 totalling 14 artists in all, receiving awards amounting to £5,875. Expenditure of £125 was incurred on administering the scheme.
