1.0 PURPOSE OF REPORT

1.1 The report brings forward proposals for the further allocation of Social Inclusion Partnerships 1 and 2 revenue funding and awards from the Small Grants Fund.

2.0 **RECOMMENDATIONS**

It is recommended that the Committee:

- 2.1 Notes the recommendations of the Dundee Partnership Community Regeneration Group in the further allocation of SIP 1 and SIP 2 revenue funding for 2001/2002, as detailed in section 6 and appendices A and B.
- 2.2 Agrees the award of Social Inclusion Partnership 1 Small Grants as detailed in Appendix C.
- 2.3 Notes the Dundee Partnership recommendation to request the carry forward of underspend in the SIP 2 programme.

3.0 FINANCIAL IMPLICATIONS

3.1 The proposed allocation of Social Inclusion Partnership 1 and 2 revenue funding, as detailed in Appendices A and B can be contained within the Social Inclusion Partnership Fund Section of the Neighbourhood Resources and Development Department Revenue Budget 2001/2002.

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 Priority has been given to revenue expenditure that is likely to be of benefit to the environment in the target areas. Also, meeting local needs is a central focus of the strategy for community regeneration and, as such, these measures will impact on numerous Agenda 21 Targets.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the Social Inclusion Partnership Fund for geographic neighbourhoods are targeted on those which fall within the most disadvantaged 10% of enumeration districts at the time of the last Census. The funding made available for the Social Inclusion Partnerships is intended to have the effect of equalling opportunities.

6.0 SOCIAL INCLUSION PARTNERSHIPS 1 AND 2 – ALLOCATION OF RESOURCES 2001/2002

6.1 Social Inclusion Partnership 1

6.1.1 Allocation of Available Resources 2001/2002

The balance of funding available within the Social Inclusion Partnership 1 programme is £32,904 comprising:

- 6.1.2 Further proposals for the allocation of funding within the Social Inclusion Partnership 1 programme are detailed in Appendix A. These will fully utilise the balance available for allocation.
- 6.1.3 A number of funding applications have not been recommended for funding by the Dundee Partnership Grants Sub Group. Details of these applications are also contained in Appendix A.

6.2 Social Inclusion Partnership 2 – Revenue Funding 2001/2002

6.2.1 The balance of revenue funding available for new initiatives up to 31 March 2002 is £26,345, comprising:

- 6.2.2 Further proposals for the allocation of funding within the Social Inclusion Partnership 2 programme are detailed in Appendix B.
- 6.2.3 A number of funding applications have not been recommended for funding by the Dundee Partnership Grants Sub Group. Details of these applications are also contained in Appendix B.
- 6.2.4 There is a remaining balance of £18,055 from the SIP 2 revenue funding allocation. The Dundee Partnership Grants Sub Group recommends that an application be made to Communities Scotland to transfer the balance to 2002/2003.

6.3 SIP 1 Small Grants Fund (Appendix C)

- 6.3.1 Awards totalling £2,450 are recommended in this report.
- 6.3.2 There is an unallocated balance of funding within the SIP 1 Small Grants Fund of £3,795. This sum has been transferred to the main Social Inclusion Partnership 1 revenue budget for allocation to other proposals (see 6.1.1 above).

7.0 CONSULTATION

- 7.1 Consultation has taken place with the Chief Executive, Directors of Finance, Support Services, and Planning and Transportation.
- 7.2 Partnership agencies, associated Council departments, community representatives and voluntary sector representatives have also been consulted and involved in the assessment of applications.
- 7.3 The recommendations are based on targets set by the Scottish Executive Development Department and Dundee Partnership targets. Area regeneration strategies for Kirkton, Ardler, Mid Craigie/Linlathen, and the Hilltown have also been considered prior to the recommendations brought forward in this report. These local area strategies take account of views expressed in a variety of consulting events within local communities.
