1.0 PURPOSE OF REPORT

1.1 The report details awards each up to the value of £500 that have been made during the financial year 2007-2008.

3.1 The 6 grant awards totalling £2,706 have been met from external grant award monies received within the Scottish Government Community Safety Partnership Funding 2007-2008. Twenty percent of the 2006-2007 Awards have received follow up audit checks as part of ongoing grant quality assurance arrangements.

- 4.1 At the Policy & Resources Committee on 28 June 2002 (Report No 71-2002) authority was given to the Dundee Community Safety Partnership to make small grant awards up to the value of £500 to voluntary/community organisations.
- 4.2 The strategic priorities for the Partnership for the period involved were as follows:
 - Tackling Substance and Alcohol Misuse
 - Improving Road Safety with Special Emphasis on Young People
 - Reducing Crime and the Fear of Crime.
 - Building and Sustaining the Community's Capacity to Participate in Community Safety Activities.
 - Reducing Antisocial Behaviour & Vandalism
 - Improving Vulnerable Individual/Group Personal Safety
 - Promoting Fire Safety and Awareness
 - Dundee Community Safety Action Plan 2007-2008

- 5.1 The awards were made to improve capacity building on local voluntary community groups to engage in community safety activities as outlined within the strategic priorities of the Dundee Community Safety Partnership Strategy & Action Plan 2007-2008.
