1 PURPOSE OF REPORT

1.1 To seek approval to the proposals and contracts for Christmas Lighting 2009.

2 RECOMMENDATIONS

Approval is recommended of (1) the Christmas Lighting display proposals as set out in this report and the attached Appendix I, (2) the acceptance of the negotiated offer by Dundee Contract Services as set out in Appendix II, (3) the inclusion of an allowance for the extension of the display at Broughty Ferry, and (4) the acceptance of the offer submitted by Scotia Animations for the display in the City Square as set out in Appendix II.

3 FINANCIAL IMPLICATIONS

3.1 The Head of Finance has confirmed that funding for the above project is available as detailed on the attached Appendix II.

4 MAIN TEXT

- 4.1 The cost of providing the city wide displays in 2008-2009 was £253,000.
- 4.2 The estimated cost of providing the same display in 2009-2010 is £255,000. This is £38,000 in excess of the budget allowance for the work.
- 4.3 Various options to reduce costs were examined. It was not possible to achieve sufficient savings to bring the costs within the budget without reducing the extent of the display in the city centre.
- 4.4 In addition to reductions in allowances for repairs to lights, professional fees and efficiency savings by Dundee Contract Services it has been necessary to delete two cross street lights in Commercial Street and Whitehall Street.
- 4.5 The adoption of these savings will bring the estimated cost within budget whilst still allowing for an extension of the display in Broughty Ferry (subject to property owners consent and further savings).
- The three year lease arrangement for the artificial tree and other decorations in the City Square expired last year. As a result an examination of the cost of reverting to a natural tree was carried out. It was established that this would cost approximately £20,000 more than extending the lease for the artificial tree.
- 4.6.1 In order for a natural tree to be provided within the available budget further deletion of lights in other areas would be required. Accordingly, that option is not recommended.

5. POLICY IMPLICATIONS

- 5.1 This Report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.
- 5.2 There are no major issues.

CHRISTMAS DISPLAY 2009

FESTIVE LIGHTING 2009 SUMMARY OF PROVISION

The proposed lighting displays comprise:-

City Square

14 metre (45 foot) Artificial tree in the traditional festive colours of red, green and white. The tree will be festooned with red bows to give daytime effect and thousands of white lights to enhance the appeal in darker hours. The red bows will be repeated on the lamp posts and attached to the east and west buildings to compliment the colour scheme of the tree. Spirals of greenery, bows and lights will be fixed to some of the columns of the Caird Hall, and to complete the display pea light cones will be affixed to the top of the lighting columns.

The two Fountains will also be illuminated.

A barrier of fir branches will be placed around the base of the tree.

The small permanent trees will be fitted with pea lights.

The colonnade at the Caird Hall will be back washed with coloured lights.

Broughty Ferry

6 No Catenary lights in Brook Street. Natural tree and lights at the library. 2 No Catenary lights in Gray Street. Extension of lights in Fort Street

Lochee

6 No lights affixed to lighting columns in High Street.

Natural tree and lights on the roundabout at the by-pass.

Westport

Natural tree and lights at the former toilets.

Seabraes (Perth Road)

Natural tree and lights at the garden area.

Whitfield

Natural tree and lights at the police station.

Stobswell

Natural tree and lights at foot of Morgan Academy grounds.
