1.0 PURPOSE OF REPORT

1.1 This report seeks approval for the payment of administrative grants for the financial year April 2007 to March 2008 to Community Councils and Neighbourhood Representative Structures in existence or established during the year, and to confirm the formulae for payment.

2.0 RECOMMENDATIONS

It is recommended that:

- 2.1 Administrative grants are awarded to all Community Councils currently in existence or established during 2007/2008 in accordance with the Council's Revised Scheme for the Operation of Community Councils (see Appendix 1).
- 2.2 Administrative grants are also awarded to other Neighbourhood Representative Structures which meet the eligibility criteria set out in Committee Report No. 725 2002 (see Appendix 1).
- 2.3 Grants are awarded according to the following formulae: a lump sum of £330 per Community Council/Neighbourhood Representative Structure plus 1.2p per resident in each area (see Appendices 1 and 2).
- 2.4 An administration grant of £440 is awarded to the Dundee Civic Forum the successor body to the Community Neighbourhood Representative Structures and the Association of Dundee Community Councils.
- 2.5 Community Councils or Neighbourhood Representative Structures established beyond 1 April 2007 will only be eligible for a grant for the part of the year from their inception.

3.0 FINANCIAL IMPLICATIONS

3.1 Costs will be contained within the Department's Revenue Neighbourhood Regeneration Fund Budget for 2007 – 2008.

4.0 SUSTAINABILITY POLICY IMPLICATIONS

4.1 Sustainability

By working in partnership with Community Councils and Neighbourhood Representative Structures, Dundee City Council will strive to develop Dundee in ways which will safeguard the future of the environment, our economy and communities.

4.2 Strategic Environment Assessment

4.3 Anti-Poverty

Community Councils and Neighbourhood Representative Structures are empowered to participate in decision-making.

Community Councils and Neighbourhood Representative Structures promote engagement in the political process and the representation of interests.

5.0 EQUAL OPPORTUNITIES

5.1 Community Councils and Neighbourhood Representative Structures encourage Dundee Citizens to participate in community life regardless of their race, colour, gender, sexuality, age, class, ethnic or religious beliefs, basic skills, disability, trade union activity or employment status.

6.0 BACKGROUND

6.1 This report details payments in the form of administration grants to Community Councils and Neighbourhood Representative Structures for the period 1 April 2007 to 31 March 2008, according to the Revised Scheme for the Operation of Community Councils and Committee Report No. 725 – 2002.

7.0 ADMINISTRATION GRANT AWARDS 2006 - 2007

- 7.1 The formulae governing the award of administrative grants ensures that Community Councils/Neighbourhood Structures receive a basic lump sum of £330 plus an additional 1.2p per resident. To be eligible for a grant, Community Councils/Neighbourhood Representative Structures must first make formal application by submitting audited annual accounts for the period 2007/2008 where appropriate. To qualify for a grant award, the applicant body should have less than twice the amount of their recommended grant in their administrative account at 31 March 2007
- 7.2 The Revised Scheme for the Operation of Community Councils, makes provision for 19 Community Councils in Dundee. At present there are 5 Community Councils: Broughty Ferry, Fintry, City Centre and Harbour, West End, and Kingsway West Community Council.
- 7.3 It is possible that during the financial year 2007-2008 that the Whitfield Inclusion Network Group (WING) may apply for recognition as a Neighbourhood Representative Structure
- 7.4 The Dundee Civic Forum enables Community Councils and Neighbourhood Representative Structures to share information, develop training programmes and promote their development.
- 7.5 Community Councils/Neigh bourhood Representative Structures established after 1 April 2007 will be awarded a grant proportionate to the number of months they are operational between 1 April 2007 to 31 March 2008.

8.0 REVIEW OF THE SCHEME FOR THE OPERATION OF COMMUNITY COUNCILS

8.1 In November 2005, the Scottish Executive issued a discussion paper entitled "What can we do to help Community Councils fulfil their role". The paper was part of a process of gathering information to identify specific obstacles and examples of good practice, thus enabling evidence-based decisions on how Community Councils can become more effective in carrying out their functions.

The recommendations emerging from the review have been considered by the Ministers and the Scottish Executive will provide further advice on which proposals they intend to take forward.

These proposals are likely to have implications for Dundee City Council's Scheme For The Operation Of Community Councils.

- 8.2 In light of the above, the Communities Committee approved the following recommendations on 19 March 2006:
 - Await further advice from the Scottish Executive on which proposals will be taken forward and the mechanism for doing so.
 - Schedule a review of Dundee City Council's Scheme For The Operation Of Community Councils in relation to 1.
 - Review the current Community Council boundaries to determine extent to which each Community Council area can be nested within the new multi-member electoral ward boundaries.
 - Delay the Community Council elections scheduled for October 2007 until April 2008 by which date the review of the Scheme For The Operation Of Community Councils will be complete.
 - Consult the Dundee Civic Forum on the intended plan of action and involve them in the review process.

9.0 CONSULTATION

9.1 The Chief Executive and Depute Chief Executives (Finance) and (Support Services) and the Assistant Chief Executive (Community Planning) have been consulted in the preparation of this report and are in agreement with its contents.
