1.0 PURPOSE OF REPORT

1.1 To advise the Committee of the recommendations and targets set in the Literacy and Numeracy Action Plan for Dundee, and to seek approval from the City Council to support implementation of that plan.

2.0 **RECOMMENDATIONS**

It is recommended that the Committee:-

- 2.1 endorses the Literacy and Numeracy Action Plan for Dundee;
- 2.2 instructs the Director of Personnel and Management Services to support the partnership to recruit staff required to implement the Action Plan;
- 2.3 instructs the Director of Neighbourhood Resources and Development to contribute to the Plan's implementation, reporting annually on progress.

3.0 FINANCIAL IMPLICATIONS

3.1 There are no direct financial implications to the Council arising from the approval of this report. Posts identified in the plan will be funded under the Government's Literacy initiative (Scottish Executive Circular Education & Lifelong Learning Department 1/01).

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 The Literacy initiative addresses many themes of Agenda 21, specifically that all sections of the community are empowered to participate in decision-making and play a full part in society.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The Literacy initiative will be targeted for those who have experienced difficulty with literacy and numeracy or who have English as a second language and who have not yet achieved Intermediate Level 1 educational qualifications.

6.0 BACKGROUND

- 6.1 The Neighbourhood Resources and Development Committee were advised in August of the Government's announcement of additional funding to address adult literacy and numeracy (ELLD Circular 1/01).
- 6.2 The allocation to Dundee's Community Learning Partnership for the current financial year is £95,723, with planned allocations for each of the next two years of £191,465 and £368,747 (a total allocation over 3 years of £655,944).
- 6.3 In order to secure release of this funding, the Executive required Community Learning Partnerships to produce a local Literacy and Numeracy Action Plan and submit the Plan by 31 December 2001.

- 6.4 The required structure of the plans was set out in subsequent guidance provided by the Scottish Executive. It includes:
 - Consultation with stakeholders including learners
 - Coherent and progressive provision
 - Needs led based on analysis
 - Partners accountable to each other

6.5 **Definition of literacy**

"The ability to read, write and use numeracy, to handle information, to express ideas and opinions, to make decisions and solve problems, as family members, workers, citizens and lifelong learners."

"Create confident, competent learners for the society we live in."

(Scottish Executive "Literacies in the Community" Report)
