4 BACKGROUND

- 4.1 During 2015/16 HMFSI commenced a programme of local area inspections of SFRS service delivery within local authority areas. The inspections examine the development of local fire and rescue plans and help to provide assurance about the way in which the SFRS is meeting this intention and explores the relationship with the local authority and other key partners.
- 4.2 The local area inspection of SFRS service delivery within Dundee City was the fifth such inspection within a local authority area to be undertaken by HM Fire Service Inspectorate. This was also the first involving the newly appointed Chief Inspector of HMFSI in Scotland.
- 4.3 The local area inspections are structured in such a way that they closely follow the structure of 'The Fire and Rescue Framework for Scotland 2013' which sets out the expectations of Scottish Government on the SFRS:
 - The Local Fire and Rescue Plan and Single Outcome Agreement
 - Improved Service outcomes and protecting frontline services
 - More equal access to specialist resources and national capacity
 - Strengthened connection between SFRS and communities
