- 6.1 The Dundee City Council Implementation Plan provides the fundamental infrastructure to allow the aims and objectives of the Tayside Area Waste Plan to be met locally, in a methodical and planned manner. The plan outlines on a year by year basis the operational projects to be undertaken to this end. The project for 2006/07 is:
- 6.2 Expansion of the domestic dry mixed recyclate collection service to include approximately 9000 further properties. These additional properties will be included in the scheme from September 2006.
- 6.3 The main new areas to be included are detailed in Appendix A, but pockets of properties adjoining existing routes but not currently offered the service will also be incorporated wherever possible.
