## 1.0 PURPOSE OF REPORT

1.1 To authorise the purchase of two waste material handlers for use in the Baldovie Waste Recycling and Processing Plant within the Waste Management Department.

## 3.0 FINANCIAL IMPLICATIONS

3.1 The total cost of the machines including servicing and warranty is £221,200. Provision for this expenditure has been made in the Waste Management Department's Capital Budget for 2009/10.

#### 4.0 MAIN TEXT

- 4.1 These machines operate in a range of waste sorting and recycling operations at the Baldovie Recycling and Processing Plant within the Waste Management Department The machines have already provided extended years service but are now beyond economic repair and in need of replacement. The existing machines are to be traded against the new machines.
- 4.2 A tender was issued to a number of machine suppliers and a summary of the tenders is attached.
