1 PURPOSE OF REPORT

To outline the initial proposals by the Local Government Boundary Commission for Scotland for 8 multi-member wards within the Dundee City Council area and to make any representation to the Commission thereon and to provide suggested names for wards as set out in the Commission's intended proposals and for wards where the Council suggests amendments or substantial changes.

2 **RECOMMENDATIONS**

- 2.1 The Council note the progress and procedures as detailed by the Local Government Boundary Commission.
- 2.2 The Council agrees the minor amendments to the Boundary Commission proposals as outlined in Section 8
- 2.3 The Council's instructions are requested in regard to any alternative proposal and the suggested ward names as laid out in Section 9.

6 BACKGROUND

A report was submitted to Dundee City Council on 18 October 2004 outlining the process for 2007 Local Government Elections using the Single Transferable Vote. At that meeting it was agreed that an advisory group to the Chief Executive be established which would arrive at 2 possible multi member ward schemes for Dundee to be submitted to the Local Government Boundary Commission. At a subsequent meeting of the Advisory Group on 16 December 2004, the Chief Executive indicated he would submit option 1 a system of 5 x 4 member wards plus 3 x 3 member wards and option 2 consisting of 2 x 4 member wards plus 7 x 3 member wards to the Boundary Commission for consideration.

In arriving at their suggestions, officers of the Council aimed for a parity target between wards of plus or minus 5% and the final submission gave a parity figure of between

2.81% above and 3.3% below for option 1 and 4.42% above and 3.65% below for option 2.

7 LOCAL GOVERNMENT BOUNDARY COMMISSION PROPOSALS

7.1 The Commission has now prepared its initial proposals for 8 multi member wards within the Dundee City Council area. The table at Appendix A shows the ward number, forecast of electorate in each ward at 2009, and the number of elected members. Maps which illustrate the Commission's proposals have been circulated to secretaries of the political groups and posted in the Councillors' Lounge.

The Commission is required by the Act to inform the Council of the reasons for any difference between its initial proposals and proposals that would have been made had it been formulated on the basis that each multi-member ward consisted of a combination of existing electoral wards. As a consequence, the Commission also enclosed an A2 schematic map showing possible multi-member wards created by aggregating the existing wards without reference to the rule set out in Schedule 6 of the 1973 Act and this again has been circulated to group secretaries and placed in the Councillors' Lounge.

The Commission has proposed a combination of 5 x 4 member wards and 3 x 3 member wards and has deviated from parity to the extent that the new ward electorate ranges from plus 7% to minus 8% which far exceeded the parameters which the Council's proposals were based on. The reasons given for the difference between the Commission's initial response on the scheme developed from the aggregation of existing wards was that the Commission has taken account of expected new housing development information provided by the Council and in the absence of any view on community boundaries within the Council area to have regard, where it was possible to do so, to community council area boundaries and to attempt a closer fit with existing neighbourhood service team areas than is possible with the aggregation of existing wards.

The resulting proposals by the Commission arguably forms a better fit in regard to natural boundaries within Dundee City as parity has not been an overriding criteria in formulating the Commission's proposals.

Officers of the Commission have been in touch with officers of the Council in regard to minor amendments around their boundary proposals but there are a number of anomalies that officers feel should be addressed in the Council representation to the Commission which are outlined in Section 8 below.

8 PROPOSED AMENDMENTS TO LOCAL BOUNDARY COMMISSION PROPOSALS

Officers of the Council have reviewed the new boundary proposals from the Local Government Boundary Commission of Scotland and are suggesting 11 amendments to the proposed boundaries. The adjustments suggested take into account a focus on preserving communities and community cohesion while recognising the natural features of an area.

The proposed adjustments along with the original LGBCS boundary proposals are indicated in the attached figures numbered from 1 to 11 and shown on the larger city-wide map on display in the City Chambers. Justification and description of the amendments are set out in the table in Appendix B.

9. SUGGESTED WARD NAMES

The Commission has also asked the Council to provide names for the proposed 8 new multi-member wards. Appendix A below provides suggested names for consideration and agreement. The suggested names have been formulated through an attempt to recognise both historical and geographically prominent features of particular areas as well as establishing a positive community identity.

10. CONSULTATION

Chief Executive, Depute Chief Executive (Support Services) and Director of Planning and Transportation have been consulted.
