#### 3. FINANCIAL IMPLICATIONS

3.1 The Executive Director of Corporate Services has confirmed that funding for the above projects is available through the Capital Plan 2021-2026 as detailed on the attached sheets.

## 4. MAIN TEXT

- 4.1 Dundee City Council has received a proportion of £5m allocation of the newly established Nature Restoration Fund (NRF) available to Scottish Local Authorities. Dundee's allocation is £109,000 of capital funding to be spent in 2021-22.
- 4.2 The purpose of the NRF is to support actions that help nature recover across Scotland. To deliver this the NRF will run across two themes:-
  - 1) Making Space For Nature (urban focused nature based solutions for biodiversity and climate change)
  - 2) Helping Nature Recover (rural focused biodiversity enhancement, climate resilience and reinstatement).

The funding allocated is to support new, or to enhance existing, approaches that further biodiversity and which adhere to the following criteria:

#### Essential

- Deliver positive effects for biodiversity and enhance local ecosystems AND / OR
- Address the climate emergency and its impacts through mitigation and adaptation andby promoting nature based solutions

#### Desirable

- Promote the health and well-being of local communities and reduce inequalities
- 4.3 It is proposed to take forward a number of capital projects contained within the Biodiversity Action Plan and which fulfil the criteria set out in 4.2. The funding will enable identified biodiversity actions to be implemented in a shorter timeframe or at an extended level. However, these projects are required to be completed within this financial year. Further details are outlined at Appendix 1.
- 4.4 The proposed projects build on existing work, particularly the biodiversity grasslands/ naturalised grasslands initiative, which has been the subject of a public survey carried out at the end of 2020. Dialogue with interested community organisations also continues. The funding will enable the enhancement of identified grassland areas in parks and open spaces which will benefit biodiversity. Other projects include the improvement of Stobswell and Den O Mains ponds to incease and protect their biodiversity value.
