#### 1.0 PURPOSE OF REPORT

1.1 The purpose of this report is to advise Committee about progress being made in the development of opportunities for young people to be involved in decision-making, following Committee Report No. 204–2013.

#### 2.0 RECOMMENDATIONS

- 2.1 It is recommended that Committee endorse progress being made in the development of opportunities for young people to be involved in decision making as described in Appendix 1.
- 2.2 It is further recommended that Committee approve a framework for ongoing improvement, characterised by the following improvement actions, to be implemented by the Communities Division Youth Work Teams:
  - Continue to support young people to ensure that they are represented at each LCPP.
  - Support young people to develop Youth Action Groups to take forward ideas for local developments as and when these arise.
  - Facilitate regular opportunities for local representatives to visit programmes and to meet young people in order to raise awareness of young people's views.
  - Support young people to develop the skills, knowledge and confidence to become more involved in local decision making.
  - Support opportunities for progression for young people who get involved in service developments as volunteers.
  - Ensure that all young people who are engaged in volunteering and/or other opportunities
    to influence policy and service developments have the opportunity to be recognised for
    their efforts through accreditation.

#### 3.0 FINANCIAL IMPLICATIONS

3.1 All costs associated with this report can be contained within the Communities Division Youth Work budget.

#### 4.0 MAIN TEXT

- 4.1 Committee Report No 204-2013 outlined a menu of actions to improve opportunities for young people to get involved in decision making. Good progress has been made overall in implementing these actions and a progress summary is attached as appendix 1.
- 4.2 In April 2014 a new National Youth Work Strategy 'Our Ambitions for Improving the Life Chances of Young People in Scotland' was launched by the Scotlish Government. One of the ambitions outlined in the strategy is to 'put young people at the heart of policy'. In Dundee, work is progressing, with partners in the field of Youth Work, to agree proposals for taking forward actions which will assist in achieving the ambitions outlined in the strategy. A report to Committee will follow when this work is complete.
- 4.3 In Dundee, developments continue at city wide and local community levels. These developments are represented by such as Dundee Youth Council and the Looked After Children/Young People Champions Board alongside support in local communities to engage

- young people in the work of groups such as Local Community Planning Partnerships (LCPP's) and Community Regeneration Fora (CRF).
- In 2013 Dundee Youth Council (DYC) launched their manifesto (Getting Young People's Point Across). The manifesto commitments are drawn from a survey of the views of around 4,500 young people in Dundee (see Committee Report 49-2013). DYC are in ongoing discussions with key people, including groups of interested young people, in order to progress the key actions and commitments made in the manifesto. This has included discussions with local bus companies about transport issues raised by young people.
- 4.5 DYC supports Dundee's Members of the Scottish Youth Parliament (MSYP's). The MSYP's are also members of DYC. There are four MSYP's for Dundee and they have regularly attended the SYP General Meetings throughout the year. MSYP's are elected every two years. The next elections are scheduled for March 2015. The elections are coordinated by DYC with support from the Communities Division's Youth Work Team and colleagues in Secondary Schools.
- 4.6 One of Dundee's MSYP's has been prominent in championing the "It's No' Fare" campaign to improve public transport for young people. A highlight of this has been an Early Day Motion tabled in the House of Commons which made specific reference to the Dundee initiative.
- 4.7 In 2013 the City Council's Decentralisation Group agreed to amend the rules governing Local Community Planning Partnerships (LCPP's) to make provision for young people to be represented at LCPP's as of right. In most circumstances the elected DYC member for the Ward area will represent young people at the LCPP. However, not every Ward area has an elected member of DYC. In this situation the local Communities Division Youth Work Team will support young people to come up with a solution and will work to ensure that, as far as possible, young people are represented at each LCPP meeting.
- 4.8 Throughout the Communities Division Youth Work programme young people are increasingly engaged in decision making. In 2013/14 over 500 young people were engaged, with Youth Work support, in influencing local and national developments. This represents a near 20% increase in the numbers engaged.
- 4.9 The following list contains some examples of the different ways in which young people in Dundee are regularly involved and are influencing local and national developments. Appendix 1 contains information about the developments that young people are influencing.
  - Advisory Groups influencing the development of local activities young people are
    engaged in the running of an activity and thus influence the ways in which the activity
    develops over time.
  - Projects such as Healthy Transitions or Peer Mentoring young people demonstrate different approaches to topics such as Health and Wellbeing and develop materials to support work with their peers.
  - The Looked After Children Champions Board young people who are or have been Looked After are engaged with Senior Officers and Elected Members in decisions about how to improve services for the LAC group in Dundee
  - Dundee Youth Council represents the views of young people in key decision making arenas
  - Members of the Scottish Youth Parliament young people who are elected by their peers to represent Dundee at a national level
  - School Project Boards young people who are involved in decisions about the development of their school
  - City Wide Pupil Council representative group drawn from the School Pupil Councils which is engaged in decisions regarding Education matters
- 4.91 It is important that young people have the opportunity to gain recognition through accreditation for their efforts. This is one way in which learning and personal development can be recorded as well as engendering a sense of personal achievement. National awards schemes such as Youth Achievement Awards, Duke of Edinburgh's Award and the Saltire Award are commonly used and have proved popular with young people. An important ongoing priority for continuing

improvement will be to ensure that there are always opportunities for young people to gain accreditation and recognition for their efforts.
