6. **BACKGROUND**

- 6.1 The Corporate Planning Department's Service Plan was approved by Committee in December 2003. This report provides an update on progress with the items contained in the Plan, and forms part of the Council's performance management arrangements that underpin best value.
- 6.2 Attached are tables which provide a concise summary of progress on each of the items in the Plan. These tables have been produced using the Strategic Plan Monitoring Database, a new system which keeps track of progress with the Council Plan and departmental Service Plans.
- 6.3 Notable achievements to date include:
 - the programme of best value reviews has been reviewed, and 14 reviews are due to report in 2005
 - a revised Community Plan was produced and launched at the first Dundee Partnership Conference in June, and a revised community involvement strategy was developed
 - the Regeneration Outcome Agreement was approved, with Dundee becoming one of the first community planning partnerships to assume responsibility for regeneration funding

- the Strategic Plan Monitoring Database went live in April
- the annual survey of satisfaction with members services showed 71% delighted, 28% very satisfied and 1% satisfied and none dissatisfied across the range of services provided
- the Better Neighbourhood Services funded project to provide support to young people received a very positive evaluation
- Dundee Discovery Card Operations Group formed and received further funding for the next two years
- 6.4 Significant areas of work planned for the coming year include:
 - new Best Value Improvement Plan resulting from the Best Value Audit
 - launch of a new customer-focused ICT strategy
 - corporate customer service team will become operational
 - availability of online transactions will be expanded
 - a new 3 year joint health improvement plan will be implemented, including joint working with the NHS on smoking prevention and cessation
 - work is underway to achieve the Scotland's Health at Work Silver Award and the department will commence the process towards an 'Investors in People' submission
