#### 1.0 PURPOSE OF REPORT

This report provides information on the operation of Dundee City Council as a Local Weights and Measures Authority for the year to 31 March 2010.

### 4.0 MAIN TEXT

- 4.1 The Weights and Measures Act 1985 requires every local authority to report, in respect of each financial year, on the operation during that year of the arrangements made to give effect to the purposes of the Act and to functions relating to weights and measures within its local area.
- 4.2 The scope of the Act is extremely wide covering the trade use of weights, measures, and equipment, and transactions in virtually all goods whether by mass or volume.
- 4.3 The data is collected on behalf of the Secretary of State by the National Measurement Office, and NMO uses the data returned by authorities to indicate the risk level of weights and measures equipment and transactions in goods, and to provide the evidence base to inform potential practical and administrative or legislative changes for the future.

#### 5.0 POLICY IMPLICATIONS
