## 1 PURPOSE OF REPORT

1.1 This report seeks approval on the necessity to stop-up lengths of roads, footpaths and footways in Mill O' Mains between Hebrides Drive and Forfar Road (A90) utilising the powers of the Town & Country Planning (Scotland) Act 1997 to accommodate a new housing development following planning consent.

## 2 **RECOMMENDATION**

2.1 It is recommended that the Committee approve the necessary Stopping-up Order for Mill O' Mains between Hebrides Drive and Forfar Road.

## 3 FINANCIAL IMPLICATIONS

3.1 The costs of preparing the Order will be met by the developer.

#### 4 BACKGROUND

- 4.1 Following planning approval to construct housing on the aforementioned area it will be necessary to stop-up lengths of road, footpaths and footways which will be removed as part of the new development. The lengths of roads, footways and footpaths on the attached plan will require to be stopped up. A new footpath link will be provided within the development opposite and adjacent to Foula Terrace connecting Hebrides Drive to Forfar Road (A90).
