1 PURPOSE OF REPORT

1.1 The Report seeks approval for the Executive Director of City Development working with the Executive Director of Neighbourhood Services to allocate the capital funding, identified in the Council's Capital Plan, for specific physical projects contained within Appendix 1, that seek to enhance the vitality and vibrancy of District Centres through improvements to the public realm and in so doing help maintain the role and function of each District Centre.

2 RECOMMENDATION

- 2.1 It is recommended that the Committee:
 - a approves the proposed District Centre Fund programme of capital expenditure, as set out in Appendix 1;
 - b delegates the Executive Director of Corporate Services to continue to review the individual projects to ensure they meet the criteria to enable them to be charged against this capital budget;
 - c delegates the Executive Directors of City Development and Neighbourhood Services to finalise the programme and approve individual projects that will improve the public realm and enhance the future vitality and viability of the district centres; and
 - d delegates the Executive Director of City Development to implement the programme of capital expenditure, following appropriate procurement processes, in order to meet the timescales associated with this fund.

3 FINANCIAL IMPLICATIONS

3.1 The Council's Capital Plan allocates £100,000 for District Shopping per annum over the period 2018/2019 to 2022/2023. The reinstatement of a clock on Lochee High Street has been partially funded from this capital allocation (£7k).

4 BACKGROUND

- 4.1 Within Dundee there are 5 District Shopping Centres Albert Street, Broughty Ferry, Hilltown, Lochee and Perth Road. The District Centres are part of the historic development of the city and have played a vital role in meeting the needs of the surrounding local communities over many years. It is recognised that their role and function is changing, influenced by the evolving behaviour of shoppers, including increased online shopping and that this has impacted on the health of these centres. As a result of the challenges being faced Officers regularly monitor the health of the District Centres (vacancy levels), retailing trends affecting them and their evolving future role.
- 4.2 Whilst there are some common challenges facing all District Centres, each area presents individual issues and opportunities. To address these challenges the Council has sought over the years to protect the role and function of district centres through the retail strategy and policies contained in the Council's Local Development Plan. The strategy and policy provision has sought to direct new retail developments to the district centres and resist out of centre

developments that would draw trade away from these individual centres. The Council has also invested in various physical improvements to maintain and enhance the public realm and create attractive shopping locations. This approach has helped to maintain the vitality and viability of each of the City's 5 District Centres over the years.

- 4.3 The Dundee Local Development Plan 2019 adopted in early 2019 recognises the need to support the future role of District Centres and maintains the strategy and policy provision of the "Town Centres First" approach making the District Centres along with the City Centre as the first choice locations for new retail and other high footfall generating uses. The Local Development Plan also seeks to encourage the continued repopulation of these areas to help sustain their vitality and viability.
- 4.4 Recognising the need to continue to support the role of the District Centres the Council's Capital Plan 2018-2023 contains an allocation of £100,000 per annum for capital projects. This is in addition to "routine" capital and revenue spending on service delivery in these areas. This funding (capital expenditure) has been allocated to invest in measures that will enhance the District Centres through public realm improvements and in so doing help promote and sustain their vitality and viability.
- 4.5 The Council carries out a health check on each District Centre every 2 years with the latest survey completed and published in 2017. The bi-annual survey provides continual monitoring of the health of the centres and has sought to identify any significant changes that might have taken place. Further survey work has taken place in 2019 to identify key trends or issues affecting the District Centres.
- 4.6 The key positon in relation to the District Centres is as follows:
 - a the trend in vacancy rates (number of units) across each of the District Centres since 2017 has varied for each centre. Lochee and Hilltown have both experienced increases in vacancy rate greater than 5%. Perth Road saw a minor increase in vacancy rates whilst there was a reduction in levels in Broughty Ferry since 2017. There was no change to overall rates in Albert Street during this period;
 - b there is a general trend to the establishment of a broader range of service based uses (as opposed to traditional retail) within the District Centres affecting smaller sized units, reflecting nationwide trends in relation to retail/service sectors;
 - c there is variation across the District Centres in terms of vacancy levels but when compared with the national position they are performing relatively well with no significant indicators of increased vacancy;
 - d the vacancy levels in 2019 within the centres of Lochee (18.4%) and the Hilltown (22%) are the only two above 10% and raise issues for consideration in terms of issues of long term vacancies, quality and/or size of unit; and
 - e there are greater opportunities for improvements to the existing public realm in, Lochee and Hilltown due to vacant gap sites and the poorer quality of the physical environment in some areas of these Centres.

5 POTENTIAL PROJECTS

- 5.1 In bringing together a list of potential projects, there have been consultations with the communities in relation to the funds to ascertain community aspirations and identity areas where the funds could have a significant impact.
- 5.2 As part of this, Community Officers, working with local community and local business groups identified potential projects. Ideas have been encouraged from a wide range of community engagement sources and have been identified within specific Community Plan themes.

- 5.3 Potential projects have been reviewed and District Shopping Fund eligible projects identified. Discussions have been ongoing with the Community Officers / Community representatives to investigate the projects in more detail and to ensure that aspirations have been correctly identified and understood.
- 5.4 Appendix 1 contains a list of the projects that have been put forward by the communities. These have been assessed in terms of their contribution to the vibrancy and vitality of the District Centres as well as an assessment in terms of their deliverability. As a result a number of projects have been identified to be delivered in the first phase of funding.
- 5.5 The identified funding will not be able to deliver all of the projects that have been identified by the communities. Further work shall be undertaken to prioritise the projects, which will include investigating further funding sources to maximise the impact of the fund.
- 5.6 If additional projects are identified by Communities, they shall be required to be reported by the relevant Communities Officer to the Planning Team. If additional projects are to be added to the list, the Planning Team shall contact the relevant Ward Members to make them aware of the project.
