#### 6.0 TENDER REPORT

- 6.1 Tenders were invited to enable the Director of Housing to appoint Contractors to carry out removals to storage or another house and return of furniture etc generally for Council tenants to allow works to be carried out within houses, as and when required over a period up to the end of March, 2006. Tenderers were requested to insert rates in the tender documents for a range of items.
- 6.2 Two sets of tender documents were prepared and issued, one to cover full house removals for large programmed works and the other for small contracts where firms were asked to provide hourly rates for labour and transport be available at short notice for individual removals.
- 6.3 Five tenders were invited for the full removals and three priced schedules were returned by the following firms:-

Alexander Removals, Dundee Dundee Removal Service, Dundee Leadingham Removals, Dundee

It is recommended that all the tenders be accepted and the Contractor selected to carry out the work for a project will be the one who will represent best value for the type of works included in that project.

6.4 Three tenders were invited for the small works but only one priced schedule was returned by the following firm:-

McIntosh Removals, Dundee

It is recommended that this tender be accepted which will provide the facility for any small works identified.
