1.0 PURPOSE OF REPORT

1.1 To outline the outcome of the review into the delivery of the existing garden maintenance service.

2.0 **RECOMMENDATIONS**

2.1 It is recommended that approval be given to the proposal as set out within this report for the provision of the Garden Maintenance Service.

3.0 FINANCIAL IMPLICATIONS

- 3.1 Costs in relation to Council and Housing Association tenants will be recharged to their respective landlord totalling £235,779. The costs associated with the recharge to the Housing Revenue Account of £175,000 will be met from efficiencies within the 2016/17 HRA Budget.
- 3.2 The implementation of these proposals will generate additional income of approximately £287,000 in 2016/17 and £338,000 in 2017/18 and beyond.

4.0 BACKGROUND

- 4.1 The Garden Maintenance Scheme is a service offered to citizens who are unable to continue to maintain their gardens due to their age or disability. The service is provided free of charge to the majority of applicants and this is based upon a level of means testing.
- 4.2 The service is currently offered to all citizens including council tenants, tenants of Housing Associations or private landlords as well as owner occupiers. All citizens qualifying for the scheme receive a level of basic garden maintenance to ensure their gardens are maintained in a reasonable condition; however it is not a fully comprehensive gardening service.
- 4.3 There are currently 1,397 gardens included in the scheme.1,246 receive a free (means tested) service. 870 gardens are either council or housing association owned while the remaining 376 are private individuals. The remaining 151 pay for the service. For the purpose of this report those clients who currently pay for the service have not been included in any of the financial costings as they are self-funding and this service would continue to be offered in the future.
- 4.4 There are currently 16 staff and 8 vehicles engaged in undertaking the Garden Maintenance Scheme and they generally operate in teams of two. Much of the maintenance work is seasonal, although a level of preparation work is undertaken over the winter months. The net cost to the council in delivering the scheme is £340,000 per annum.
- 4.5 This is a non-statutory service and there are a number of different approaches taken by other local authorities across Scotland to the provision of Garden Maintenance services. A 2014 survey of other authorities was undertaken and the results provided in Appendix 1. Responses were received from seventeen authorities and are summarised as follows:
 - Provision of GM service

- Provision of GM service to non-council tenants
 47%
 - Free/means tested service to council tenants 53%
- Free/means tested service to non-council tenants
 24%
- 4.6 Of those authorities that provide a garden maintenance service there are a range of charging policies applied and details of these are given in Appendix 1. These policies range from completely free to full re-charge, some apply means testing whilst some do not and some charge owners whilst others do not.

5.0 PROPOSALS

- 5.1 It is proposed that:-
 - The costs of the service in relation to Council tenants and Housing Association tenants are recharged to their respective landlords. This proposal will deliver an income of £235,770 based on an individual charge for a garden of £271 multiplied by the number of gardens 870.
 - A charge will be levied to all other recipients of the free service and will be phased in over a 2 year period. Work will be undertaken to develop a social enterprise as an alternative option for those service users.
 - Continue to deliver a service to those individuals who pay and seek opportunities to grow this market.

6.0 LEVY CHARGE DIRECT TO HOUSING ASSOCIATION/COUNCIL NEIGHBOURHOOD SERVICES HRA

6.1 At the present moment the service is delivered at no charge to Housing Associations and Council tenants. Currently the total number of gardens maintained for Housing Associations and Council Housing tenants totals 870 at a cost of £235,770.00.

7.0 PRIVATE INDIVIDUALS WHO CURRENTLY RECEIVE NO CHARGE

7.1 There are 376 private individuals who currently receive a free service at a cost of £101,896.

It is proposed to commence charging for this service from April 2016 and in order to reduce the impact, that the charges are introduced over a two year period. The proposed charges are maximum charge equivalent to £2.60 per week over a 52 week period from 1^{st} April 2016 and which will rise to £5.20 per week from 1^{st} April 2017. This will generate additional income of £50,835 in 2016/17 and an additional £50,835 in 2017/18.

7.2 As a further measure to reduce the charge impact, it is proposed to develop a partnership with a social enterprise who would take on the future delivery of the garden maintenance service for those non paying clients. Informal meetings have been held with the Network Manager from the Dundee Social Enterprise Network (DSEN) and it is clear that there may be an interest in this project. The development of this partnership would require to be considered in due course.

8.0 POLICY IMPLICATIONS

8.1 This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management. An Equality Impact Assessment is attached.

9.0 CONSULTATION

9.1 The Chief Executive, Executive Director of Corporate Services, Head of Democratic and Legal Services and the Dundee Social Enterprise Network have been consulted on the preparation of this report.
