1. PURPOSE OF REPORT

1.1 To inform the Committee of fixed prices submitted by suitable suppliers for new grounds maintenance plant and equipment required by Dundee Contract Services for the financial year 2004/2005.

2. RECOMMENDATIONS

- 2.1 It is recommended that the lowest or most advantageous offer as assessed under "Best Value" criteria is accepted for each category of plant required.
- 2.2 The successful supplier in each case is listed below. See Appendix 1 for price comparisons and assessment summaries.

The contracts will be awarded to the lowest or most advantageous offer for each category of plant as assessed under "Best Value" with emphasis placed on operational needs, operator response, reliability, after sales service and long term costs of ownership.
