1.0 PURPOSE OF REPORT

1.1 This report makes recommendations for further awards under the Small Grants Programme.

The report also informs the Committee about two funding applications being made by the Social Inclusion Partnership for additional resources to 1) tackle drug misuse and 2) promote arts work in SIP1 areas.

2.0 RECOMMENDATIONS

It is recommended that the Committee:

- 2.1 Agrees the award of SIP1 Small Revenue Grants as set out in Appendix B.
- 2.2 Notes the two funding applications made by the Social Inclusion Partnership, as detailed in sections 6.1 and 6.2.

3.0 FINANCIAL IMPLICATIONS

- 3.1 The proposed allocation of SIP1 Small Revenue Grants, as detailed in Appendix B can be contained within the Social Inclusion Partnership Fund Section of the Neighbourhood Resources and Development Department Revenue Budget 2000/2001.
- 3.2 The total cost of proposals contained in the drug misuse funding application is £35,000 in 2000/2001 and £35,000 in 2001/2002. If the application is successful, the full cost of the proposals will be met by an additional grant payment to the Council from the Scottish Executive.
- 3.3 The total revenue cost of the application to the Arts and Social Inclusion Lottery Funding Scheme is £181,250 over three financial years, from 2001/2002 to 2003/2004. It is intended to submit a SIP1 funding application for £40,000 in the next round of applications. Approval of the project will be subject to the SIP revenue funding being awarded.

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 Priority has been given to capital and revenue expenditure that is likely to be of benefit to the environment in the target areas. Also, meeting local needs is a central focus of the strategy for community regeneration and, as such, these measures will impact on numerous Agenda 21 targets.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the Social Inclusion Partnership Fund for geographic neighbourhoods are targeted on those which fall within the most disadvantaged 10% of enumeration districts at the time of the last Census. The funding made available for the Social Inclusion Partnerships is intended to have the effect of equalling opportunities.

6.0 APPLICATIONS FOR ADDITIONAL FUNDING

Recently, the Social Inclusion Partnership 1 (Geographic) was invited to submit funding bids for two specific areas of work, as detailed in sections 6.1 and 6.2:

6.1 Tackling Drugs Misuse

The Scottish Executive is making £2 million available over the next two years to help tackle drug misuse in Social Inclusion Partnership areas. The purpose of the funding is to tackle some of the root causes of sustained and damaging drug misuse.

Dundee's SIP1s provisional allocation is £35,000 in 2000/2001 and £35,000 in 2001/2002.

A proposal was drawn up in consultation with the Dundee Drug and Alcohol Action Team (DAAT) which is chaired by the Director of Social Work. The proposal is attached at Appendix A.

The proposal contains a number of initiatives that will tackle drug misuse in the four SIP1 communities by preventative and diversionary work and also, where appropriate, by direct work with drug users.

The proposal was submitted to the Scottish Executive on 30 June 2000. Following an assessment period it is anticipated that the outcome of the application will be known in mid August. A further report on the outcome of the application will be brought to Committee in due course.

6.2 Arts and Social Inclusion Lottery Funding Scheme (The Scottish Arts Council)

In April 2000, the Scottish Arts Council invited all Social Inclusion Partnerships to submit applications for funding to support arts work in SIP areas. This funding, totalling £300,000 in 2000/2001, is available through the National Lottery Arts and Social Inclusion Scheme. The maximum grant available over three years is £100,000.

A bid has been drawn up by the Arts and Heritage Department in conjunction with NRDD. The bid will aim to:

- Extend opportunities to those not currently accessing the arts, building on the success of city centre arts initiatives.
- Create a new live drama performance confronting arts prejudices, engaging new audiences and participants with arts providers in an interactive role.
- Offer new arts experiences through use of community and school networks.
- Link local community initiatives (for example community festivals) with arts providers/ agencies.

The final draft of the proposal was presented to the Dundee Partnership Grants Sub Group on 2 August 2000 for its consideration and approval.

The total cost of the proposal is £181,250 over three years, from 1 April 2001, of which £100,000 is being requested from the Lottery Scheme. Sources of funding for the balance of £81,250 are proposed as follows:
