**1. PURPOSE OF REPORT**

- 1.1 This report details a quotation for the upgrading of monitors and the provision of additional video tape review facilities at the central monitoring station at Tayside Police HQ, Bell Street, Dundee.

**2. RECOMMENDATIONS**

- 2.1 Approval is recommended of acceptance of the quotation submitted by ADT Fire and Security plc, Dundee in the amount of £15,057.77.

**6. FURTHER INFORMATION**

- 6.1 A bid was made to the Scottish Executive Justice Department, Crime Prevention Unit in November 2002 for a grant towards various CCTV initiatives. Out of a total grant application of £447,000 the Council was awarded funding of £15,000 towards replacing the monitors within the control room.
- 6.2 Discussions were held with the appointed maintenance contractor, ADT Fire & Security plc and subsequently a quotation was received for replacing 27 of the 49 monitors and installing additional review facilities.
- 6.3 The quotation received is considered fair and reasonable for the work involved.

- 7.1 The Chief Executive, Depute Chief Executive (Support Services) and Depute Chief Executive (Finance) have been consulted and are in agreement with the contents of this report.
