- Evidence of sound organisational and financial management
- Production of a balanced project budget identifying eligible costs up to the sum applied for.

- To assist non-profit organisations undertake short-term leisure and arts projects in Dundee
- To complement the Leisure and Arts Department's priorities and public programme

### **Assessment Criteria**

- The extent to which the project increases public access to leisure and arts opportunities
- The extent to which the project complements, or adds to, already existing provision
- The impact of Council support on the viability of the project
- Evidence of ability to deliver the project, with sound organisational and financial management
- Production of a balanced project budget.

Broughty Ferry Environment Project is a registered charity and is a locally managed community group set up to encourage local environment projects and raise awareness with regards to environmental issues. The Daisy Chain is a time-lapse film loop project. This will involve local people taking photographs at regular intervals of the local landscape. These photographs will then be complied into a professionally made time-lapse loop video with commentary. The video will be projected onto a large screen at an outdoor venue e.g. Reres Hill. Wasps Artists Studios – Wasps Open Doors	Wasps Ltd. (Workshops and Artists Studio Provision Scotland) is one of Scotland s largest visual artists charities. The organisation provides affordable workspace for 750 artists each year in city, rural and island locations in Scotland as well as offering exclusive discounts on arts materials, new graduate discounts and exhibiting and international exchange opportunities for artists. Wasps currently support 48 artists at Meadow Mill Studios in West Henderson's Wynd. Wasps Open Doors will take place on the weekend of 4 <sup>th</sup> and 5 <sup>th</sup> October 2003 with up to 48 artists at Meadow Mill opening their workspaces to the public. The aim being to increase public awareness of artists working in the City, link Meadow Mills Studios with the city's burgeoning cultural quarter, raise the profile of visual arts in Dundee amongst a local and national audience and create sale and exhibiting opportunities for Dundee based artists.
