1.0 PURPOSE OF REPORT

1.1 To seek authority to purchase a replacement forklift-truck for use at the Marchbanks Recycling Plant within the Waste Management Department.

2.0 RECOMMENDATIONS

2.1 It is recommended that the committee accept the offer from Finning Material Handling, Staffordshire amounting to £19,520 (including trade-in of existing unit).

3.0 FINANCIAL IMPLICATIONS

3.1 The total cost of the machine is £19,520. Provision for this expenditure has been made in the Waste Management Department's Capital Budget for 2006-07.

4.0 LOCAL AGENDA 21 IMPLICATIONS

- 4.1 Health is protected by creating a safe clean pleasant environment.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 Under the Local Government Act 1988, suppliers were required to complete and return a questionnaire to ensure that their business complies fully with the Race Relations Act 1976. All companies listed comply fully with the Act.

6.0 MAIN TEXT

- 6.1 The Recycling Plant at Marchbanks handles a range of materials for recycling (including glass, paper, aluminium cans etc) and these materials require to be handled and loaded onto vehicles for processing.
- 6.2 One of the two existing forklifts is now beyond economic repair and is in need of replacement.
- 6.3 Tenders were sought from suppliers for a replacement unit. Suppliers were asked to provide a discount for the trade in of the machine being replaced. A summary of the tenders is attached. The machine recommended is marginally more expensive than two of the alternatives, however extensive demonstration trials were carried out onsite and the machine recommended was proved to offer the best safety features.
